LOCATION

The premises are located in the established Glencairn Industrial Estate, which lies 1.3 miles to the south of Kilmarnock Town Centre and is accessed off East Shaw Street.

The estate benefits from excellent transport links, with the A77 within minutes' drive providing convenient access to Glasgow and the M8 via the M77. The A71 also provides links to Irvine and the west, and an alternative direct route to the M74 and Edinburgh.

Kilmarnock is the administrative centre for East Ayrshire and lies 25 miles to the south west of Glasgow and 12 miles north east of Ayr.

DESCRIPTION

The property comprises a gable end, light industrial unit of steel portal frame construction, with brick work cladding to approximately 2.75m and profile sheet metal cladding above. The pitched roof is covered with a profile sheet metal finish incorporating translucent panels to provide natural light.

The premises benefits from a trade counter area and small office accommodation finished with vinyl and carpet tile floors, and suspended ceiling incorporating recessed lighting. The warehousing space is accessed via a vehicle roller shutter door, and is well spec'd with a concrete screed floor, flourescent lighting and a gas fired hot air heater. There is also a steel built mezzanine level for additional storage.


ACCOMMODATION


