

Description

The arch is suitable for a variety of industrial and business uses. The unit, which is lined and of brick construction, with a concrete floor. There are electric roller shutter doors on either side, with separate pedestrian entrances. These lead to a loading area in the shared yard at the rear and onto Mentmore Terrace to the front. The unit benefits from a 3-phase power supply, water and W/C facilities with a small kitchenette provision.

Location

The property is well located on Mentmore Terrace, less than 50 metres from the London Fields Overground Station. As a result, there are many populous locations within a short train journey.
