LOCATED IN CENTRAL LONDON

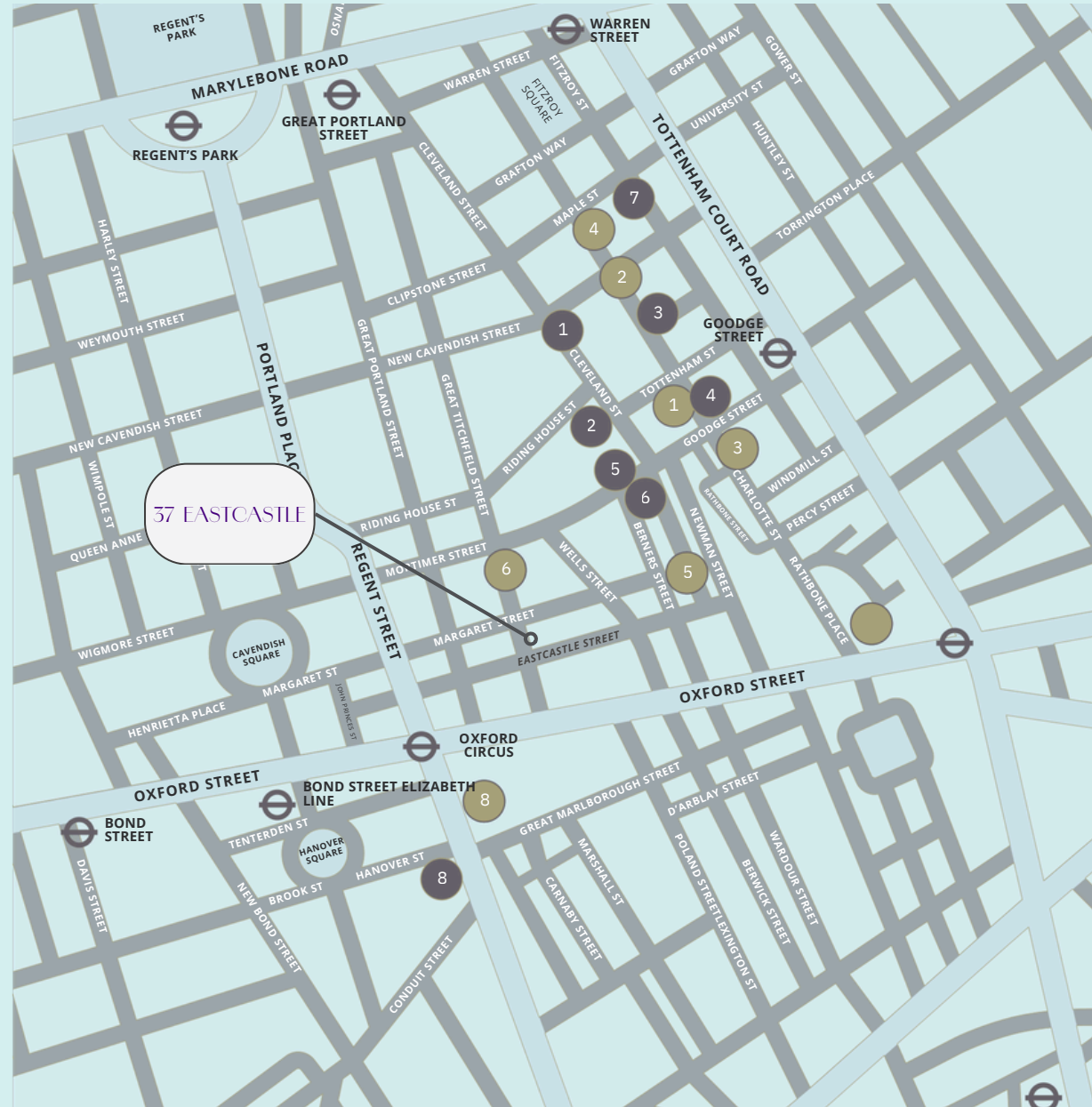
