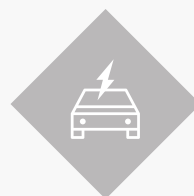

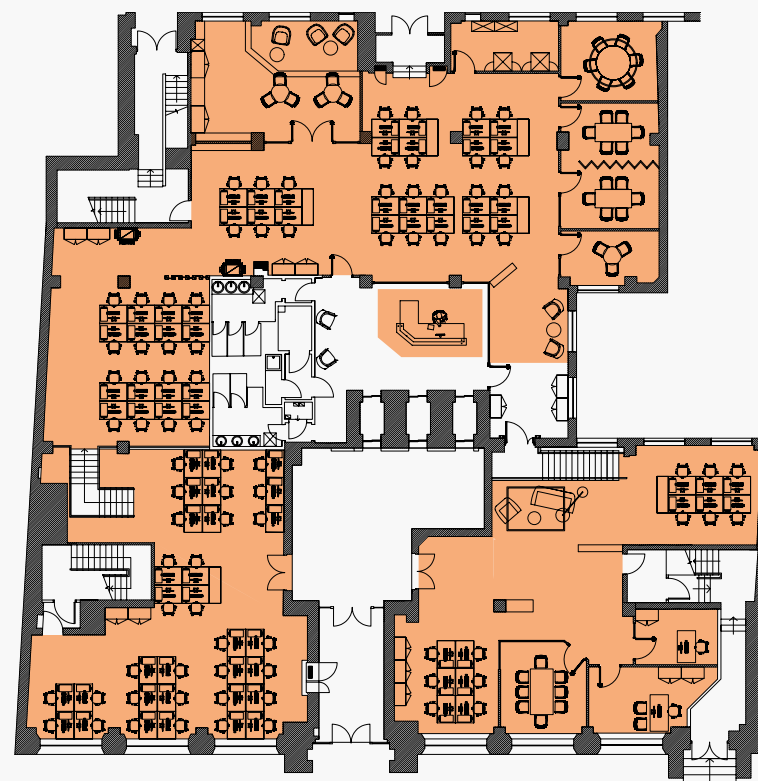

The floor can also be split into two smaller suites if required, offering flexibility to suit your business needs.



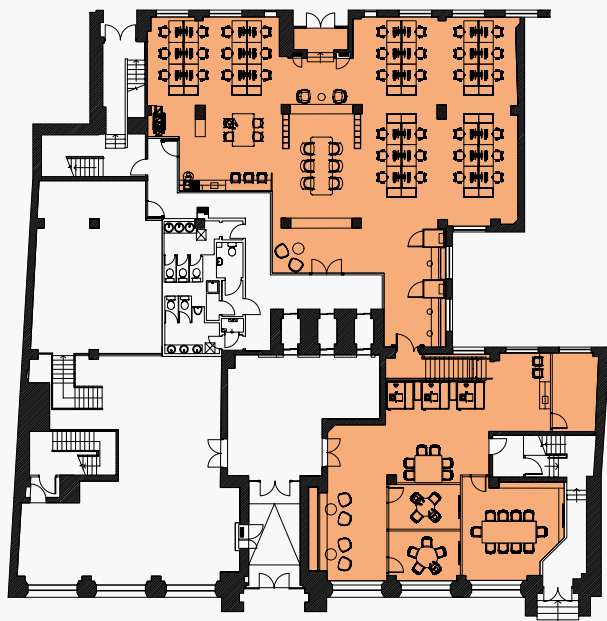
