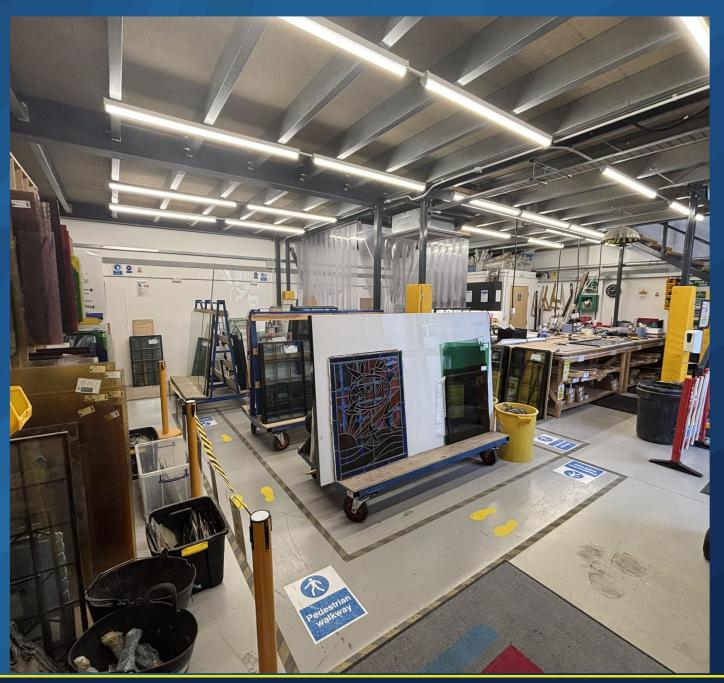

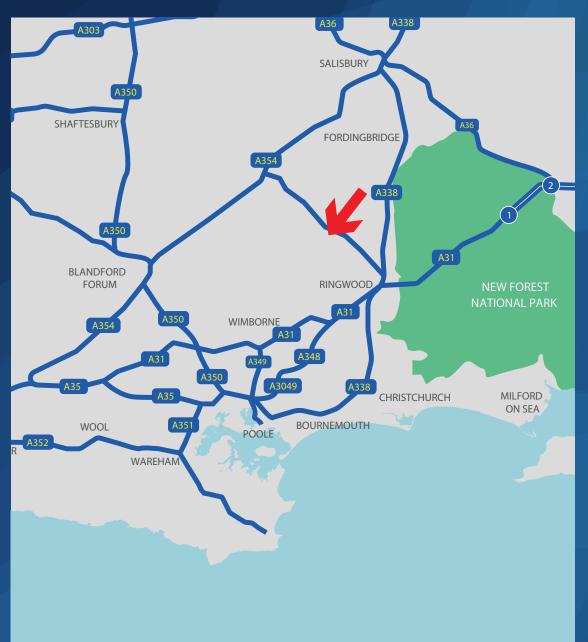

LOCATION

The property is located on Axis 31 which is a modern industrial estate forming part of Woolsbridge Industrial Park at Three Legged Cross, Wimborne.

Axis 31 is accessed from Ringwood Road and is located approximately 2.5 miles north-west of the A31 which is main route linking Wimborne, Ferndown and Ringwood. The A31 provides dual carriageway access to the M27 to the north and A35 to the west.



DESCRIPTION

The property comprises a modern, mid-terrace industrial/warehouse unit of steel portal frame construction with brick outer walls and blockwork inner wall construction, with composite panel cladding to the upper elevations. The unit has an insulated steel clad roof incorporating daylight panels.

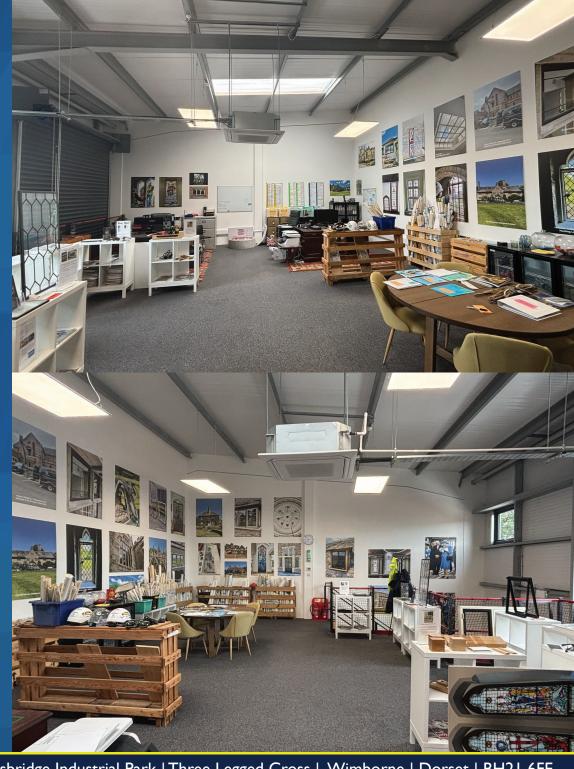
