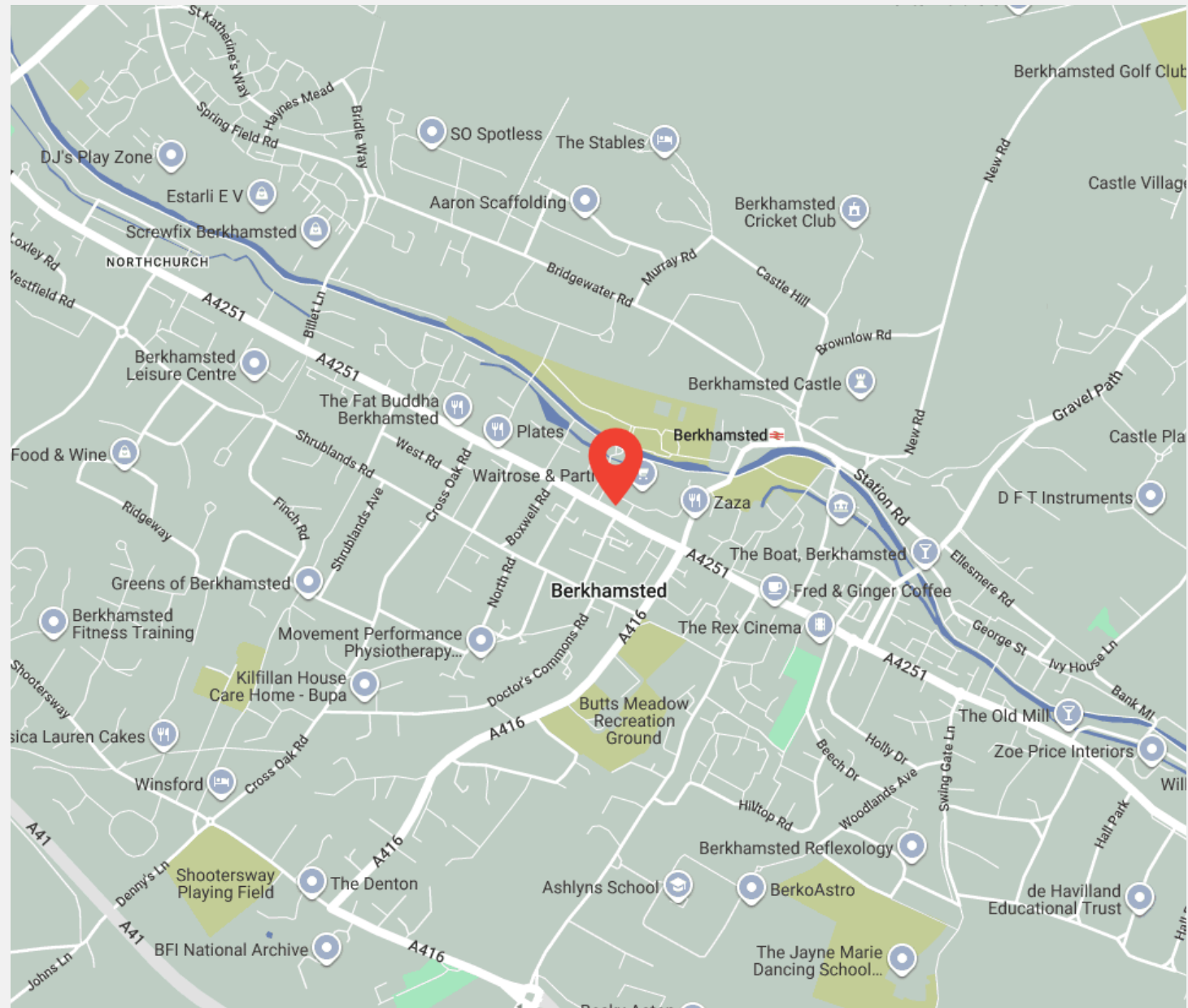
The property benefits from air conditioning, natural light and one car parking space.
