#### **LOCATION**

Located at the south west end of Kennington Lane, the premises occupy a prominent position in this busy local shopping area serving the surrounding residential and commercial locality, less than 150 metres from Vauxhall mainline, Underground and bus stations.

The wider area has and continues to undergo extensive residential and commercial redevelopment including the high profile schemes on Bondway, Nine Elms Lane and New Covent Garden, all situated just to the south and west of the property.

#### **DESCRIPTION**

Comprises an end of terrace unit with double frontage arranged over ground floor and basement.

The ground floor provides a main open plan space with small raised rear part and meeting room, whilst the basement is arranged with two ancillary rooms plus kitchen and two w.c.s at the rear. The floors are interconnected by an internal stair at the rear. There is also a rear yard providing parking spaces, accessed from Harleyford Road.
