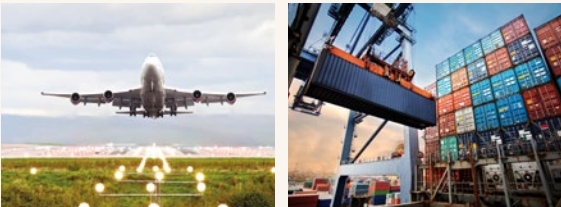
STRATEGIC LOCATION

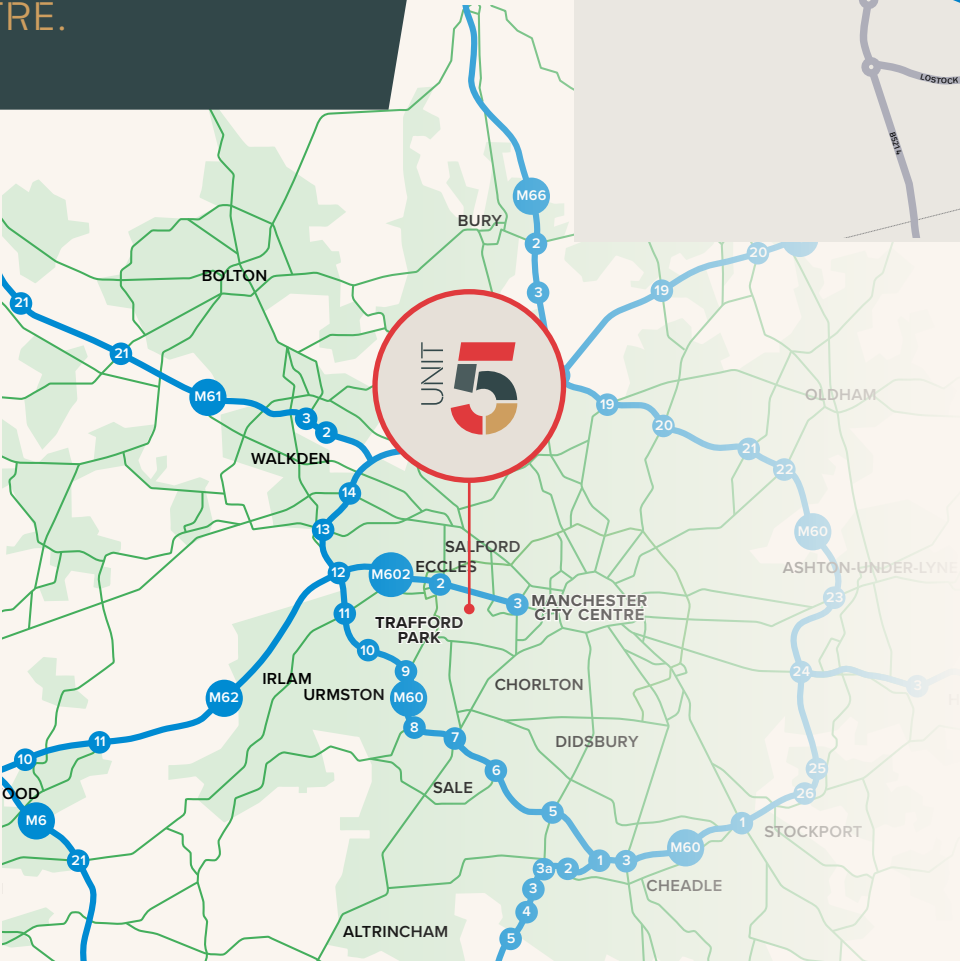
The property is accessed via Pacific Way with excellent onward links to the M60 and M602 motorways.
