Marchwood Industrial Park is a wellestablished industrial site and home to more than 60 businesses.

The newly refurbished property comprises a detached warehouse unit of steel portal frame construction, with inner blockwork and full height profile cladding. Access to the unit is by 5 electric level loading doors. There is a central core with refurbished reception/office, kitchenette and cloakrooms to the ground floor and first floor offices. The warehouse benefits from LED lighting, with LED lighting also installed throughout the offices.

Externally, the site is palisade fenced with 2 separate vehicular access points.
