












#### Location



#### **Planning**

Planning Permission was approved with conditions, on Thursday 21<sup>st</sup> December 2023, for the residential development of up to 140 dwellings (access only) at the former Riverside Mill site and land bordering with Charles Street and Baker Street, Reedyford Road, Nelson, Lancashire (Ref: 22/0774/OUT).

#### **Planning Obligations**

There is no prescribed level of affordable housing in Pendle and the selected developer will be required to submit a viability assessment to determine the number of affordable homes that should be delivered. The tenure split of the affordable dwellings should be 80% social rented and 20% intermediate housing. Unless otherwise agreed in writing by the Local Planning Authority, the S.106 has stipulated that the said obligation shall comprise an education contribution.

#### Tenure

The site is held part freehold and part leasehold. Land registry details are available for consideration within the dataroom.



#### **Ground Conditions**

A phase I and a phase II investigation report is available for interested parties to satisfy themselves as to ground conditions prior to entering a purchase contract.
