



## TERMS & RENT

The available accommodation is offered to let on a new, inclusive lease for a preferred term of 3 years. Leases will be outside the Landlord and Tenant Act. Studios on level 6 are potentially available on shorter contracts.

**The rent will be inclusive of service charge, insurance, electricity and broadband.** Excludes business rates. VAT and service charge may be applicable.

## RATES

The rateable value of the suites are separately assessed.

The rates payable depend on the occupier's circumstances and can be obtained from either Norwich City Council (Business Rates: 0344 980 3333), or via [www.gov.uk/correct-your-business-rates](http://www.gov.uk/correct-your-business-rates) which includes a rates payable calculator.

Qualifying occupiers may be entitled to 100% rates relief (£0 payable) on properties with a rateable value of less than £12,000.
