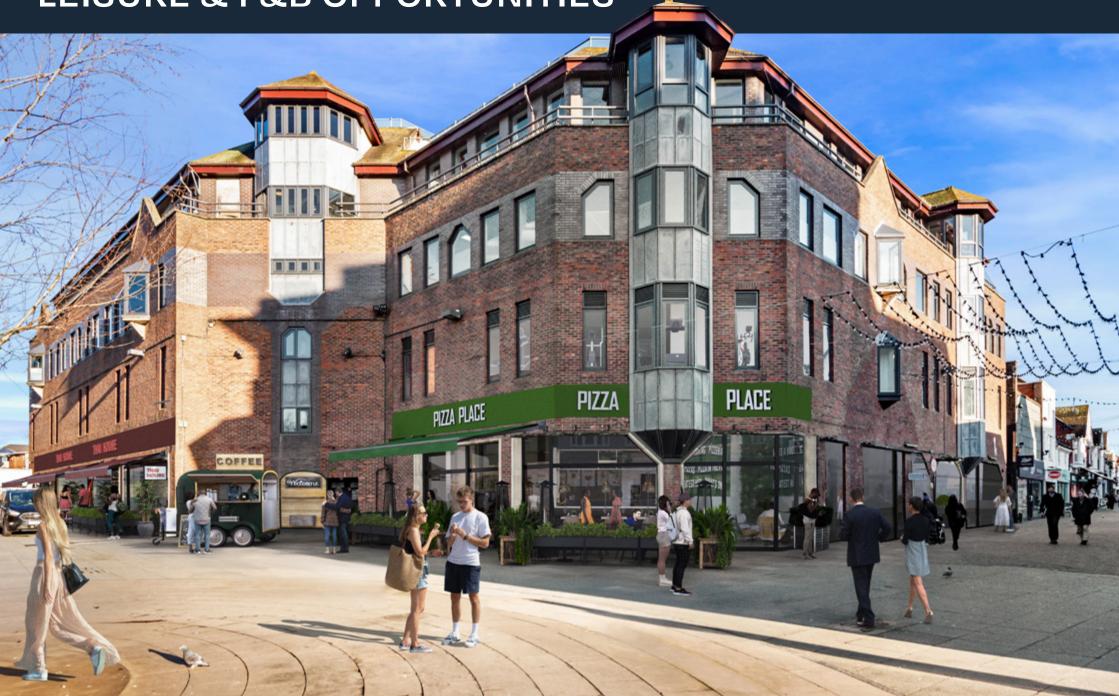
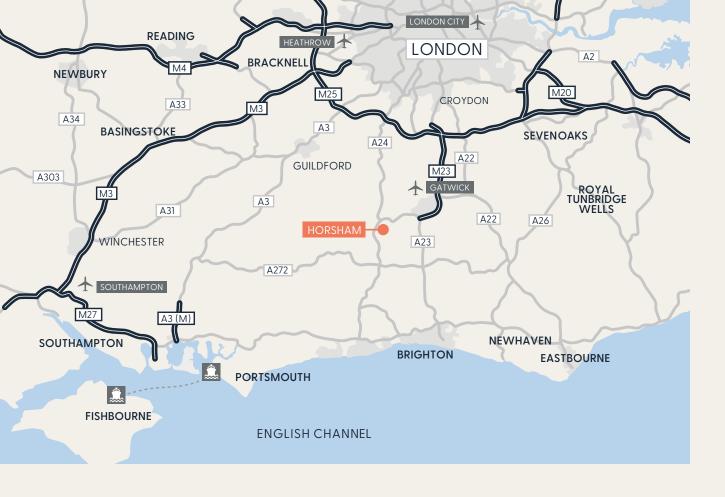

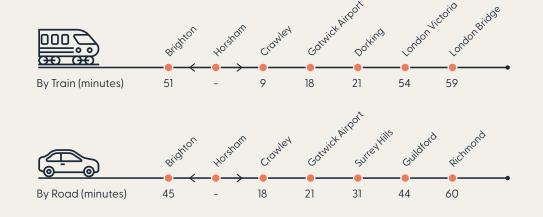
Horsham is an affluent and attractive town in the South East England, 33 miles south of London.

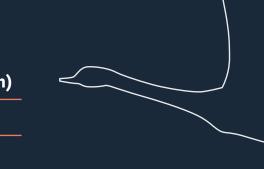


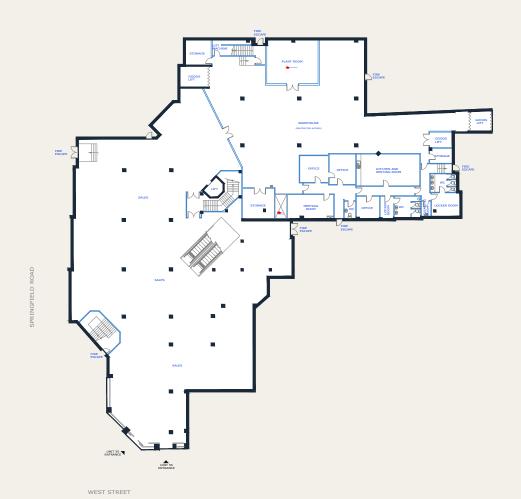

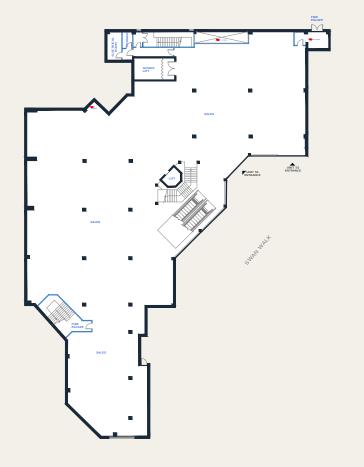
