



OUTLINE PLANNING PERMISSION TO PROVIDE UP TO 126 PRIVATE DWELLINGS

LOCATION & DESCRIPTION



Location

The site lies to the north of Cutbush Lane approximately 500 metres to the east of its junction with the A327 in a semi-rural residential location on the outskirts of the village of Shinfield, Berkshire, approximately 3.5 miles to the south of Reading town centre.

The A329(M) and Junction 11 of the M4 motorway lie approximately 5 miles to the north east and 1.5 miles to the west respectively.

Reading Railway Station lies approximately 3.5 miles to the north, providing direct train services to London Paddington.

The immediate vicinity provides a mix of two and three storey houses and flats and agricultural land.

Description

A copy of the illustrative masterplan (Drawing No. DR-471-101) accompanying these particulars of sale shows the approximate boundaries of the site edged in red.

The property comprises an irregular shaped site currently used as agricultural land. Within the north part of the site is an area of woodland in addition to a former reservoir (now drained). The topography of the site is determined by the valley line which runs north-south through the middle of the site. The valley divides the site into two planes, one sloping down from west to east and the other sloping down from east to west.

The property is bordered by Cutbush Lane at its southern boundary and two storey private houses and flats at its western boundary. At its northern and eastern boundaries the property is bordered by agricultural land that has been granted planning permission for the first phase of the University of Reading's Science and Innovation Park and the Shinfield Eastern Relief Road (ERR). The site will have direct access to the ERR but for pedestrians, cyclists, buses and emergency vehicles only. The primary vehicular access to the site is via Cutbush Lane.

The total site area is approximately 7.33 hectares (18.11 acres).

Tenure

The property will be sold freehold with full vacant possession given on completion.

Planning

The property has outline planning permission for "a residential development comprising up to 126 dwellings, public open space, children's play areas, accesses to Cutbush Lane and the Shinfield Eastern Relief Road, landscaping, ecological buffer zone, ground modelling, sustainable drainage systems and associated infrastructure" which was granted on 24th December 2013 (application reference: 0/2013/0101). All relevant reports, drawings and documents relating to this planning permission are included in the technical information pack.

The outline planning permission is subject to a Section 106 Legal Agreement dated 23rd December 2013 requiring a commuted sum in lieu of on-site affordable housing of £3,500,000 and financial contributions totalling £3,475,889.99 (index linked) payable to Wokingham Borough Council.

Shinfield Eastern Relief Road (ERR)

Planning permission for the ERR was granted at appeal on 8th November 2012. The vendor is currently procuring delivery of the ERR which is expected to be completed in early 2016.

For the avoidance of doubt, the purchaser will be responsible for payment of all financial contributions payable under the S106 Agreement.

The contributions are index linked from the date of the S106 Agreement (23rd December 2013) with the exception of the ERR Contribution which is index linked from 15th November 2011.

The purchaser will be required to covenant with the vendor to comply with the S106 obligations and not to negotiate any change to them without the consent of the vendor.

Suitable Alternative Natural Greenspace (SANG)

Wokingham Borough Council agrees that delivery of the Loddon SANG would avoid any impact upon the Thames Basin Heath's Special Protection Area (SPA) arising from the redevelopment of the land north of Cutbush Lane. The vendor has secured planning permission (application reference F/2010/1434) for the Loddon SANG and will undertake to deliver it prior to occupation of the first dwelling at the site.

Services

Mains electricity, gas, water and drainage services are available in the vicinity for connection to the property. However, prospective purchasers are advised to make their own independent enquiries of the individual authorities to verify the capacity and availability of such services.

The vendor has secured electricity capacity for the proposed development from Scottish and Southern Energy at a cost of £94,379.59. The benefit of that secured capacity will be passed to the purchaser upon completion and this cost to the vendor should be reflected in the offer.

Site Surveys

The vendor is commissioning ground condition investigations at the site, the results of which will be passed to the purchaser.

METHOD OF SALE

Method of Sale

The property is offered for sale by way of informal, non-binding tender with the vendor reserving the right not to accept the highest or any offer and also reserving the right to withdraw the property from sale or to vary the method of sale at any time without notice. In the event that a number of competitive offers are received, the vendor reserves the right to request 'best and final' offers from selected parties.

All offers must be made subject to contract only and net of S106 costs and other anticipated abnormal costs associated with the development of the site. Any anticipated abnormal costs should be clearly quantified in the offer letters.

Unconditional offers must be made in writing for a fixed sum. Exchange of contracts is to take place within four weeks of receipt of the draft sale contract with a 10% deposit payable.

Completion is to take place within four weeks of exchange of contracts with the full balance of the purchase price payable immediately upon completion of the sale.

Special Conditions of Sale

Fencing Covenant

The purchaser will be required to erect a 6' high close board fence of good quality (precise specification to be agreed with the vendor) along the property's north-western boundary between the site and the vendor's retained land, within 28 days from completion.

Restrictive Covenant

The property will be sold with a restrictive covenant in favour of the vendor's retained land, restricting its development to up to 126 dwellings.

Pedestrian Pathway

Following completion of the sale, the purchaser will be required to construct a pedestrian pathway from between points A and B on the illustrative masterplan to a neighbouring local equipped area for play (LEAP) in Wokingham Borough Council's ownership.


