## LOCATION

Links Street is an established industrial location situated within the Port of Aberdeen, lying in close proximity to Aberdeen City Centre. The area benefits from immediate access to Aberdeen Beach and the Beach Boulevard, providing direct links to the city centre, Aberdeen Harbour and the wider road network.

## DESCRIPTION

The property comprises a modern mid-terrace industrial unit of steel portal frame construction. Internally, the accommodation provides an open-plan workshop with dedicated office accommodation and WC facilities positioned to the front of the unit.

The specification includes:

- Insulated profile metal sheet cladding
- Designated office accommodation
- WC facilities
- Eaves height of approximately 4.0 metres
- LED high-bay lighting
- Roller shutter vehicular access door
- Three-phase electricity supply

Two dedicated car parking spaces are provided to the front of the unit, with additional communal parking available within the estate
