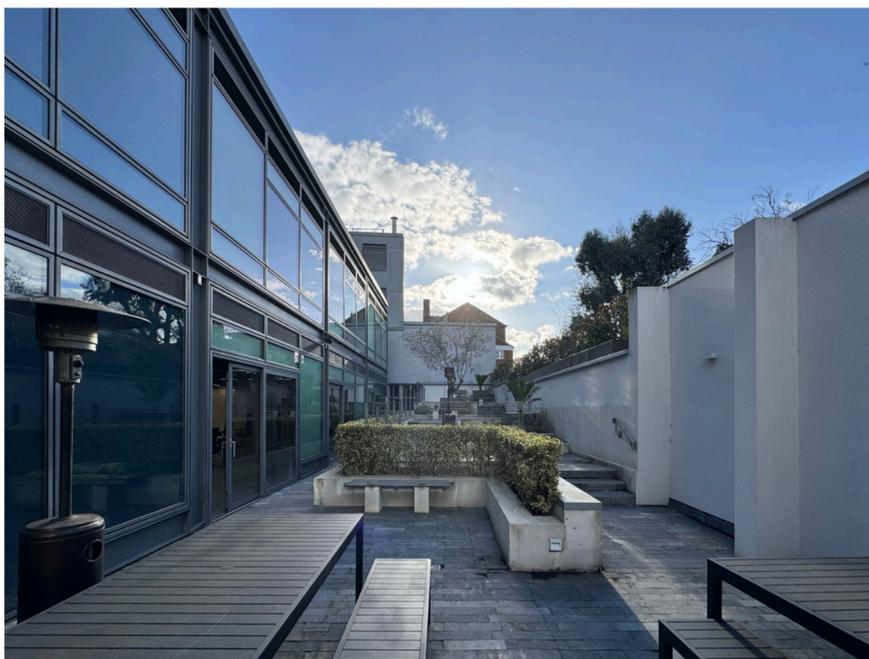
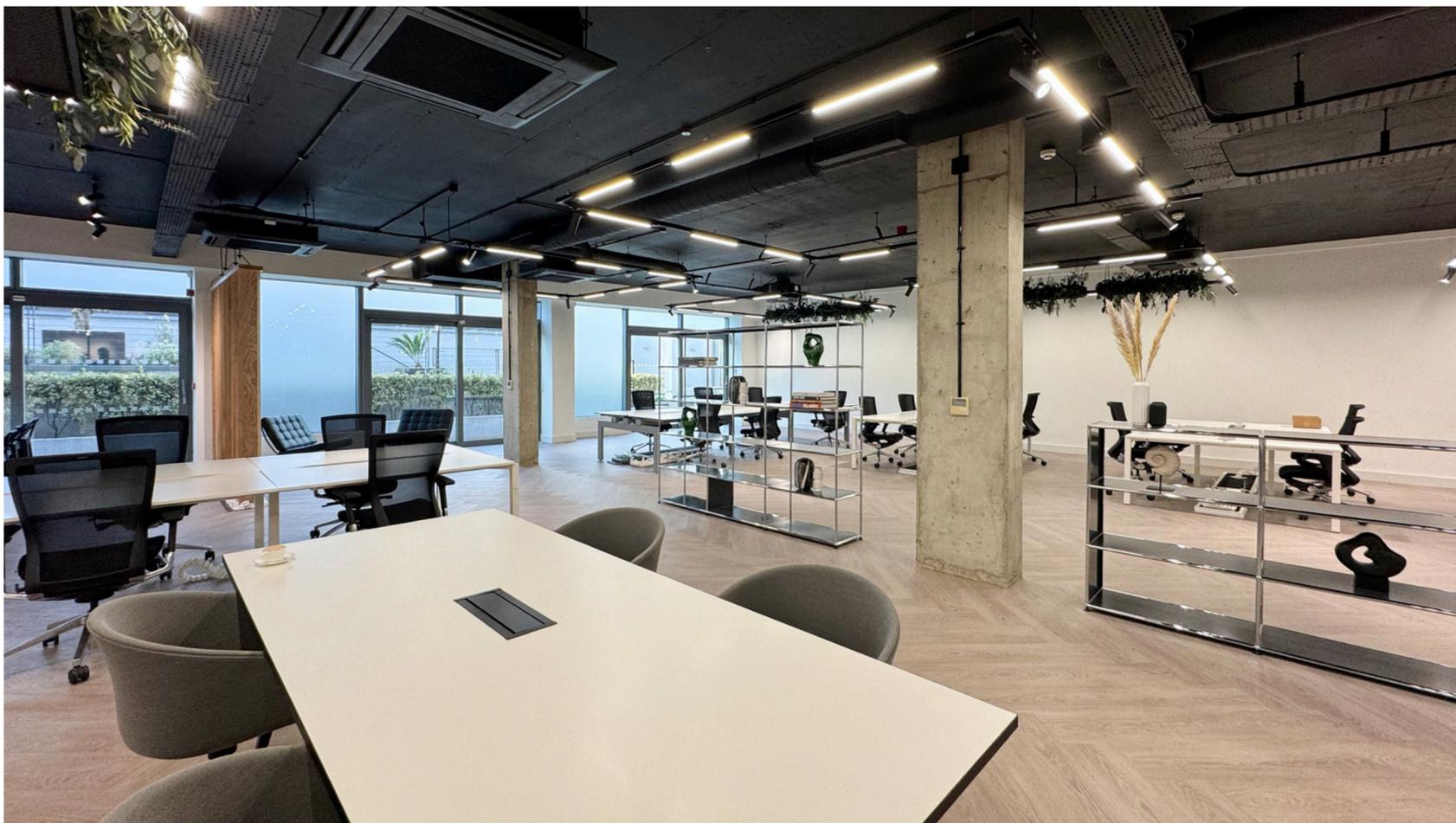

The site benefits from a corner café that offers a vast array of breakfast and lunch options. The property is also within walking distance of the vibrant Camden.

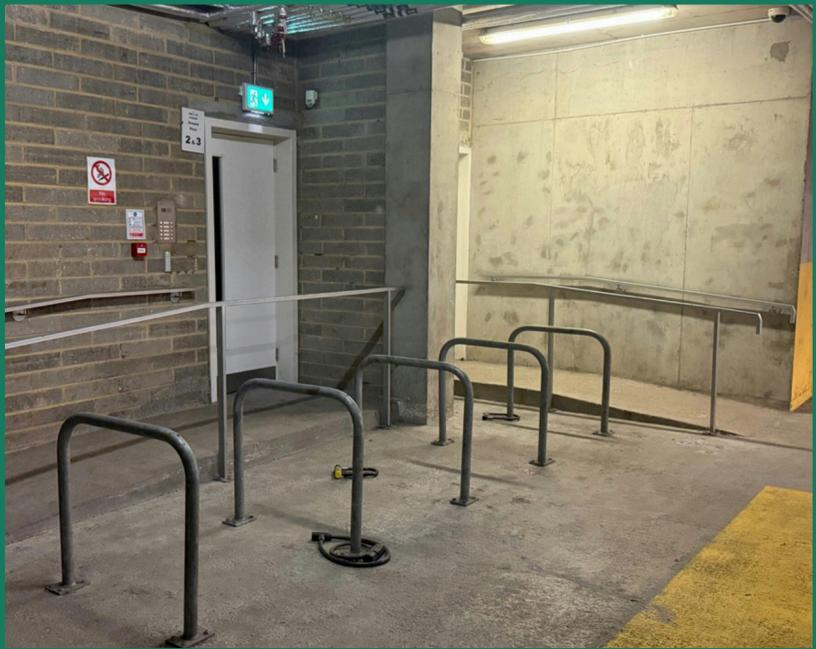
