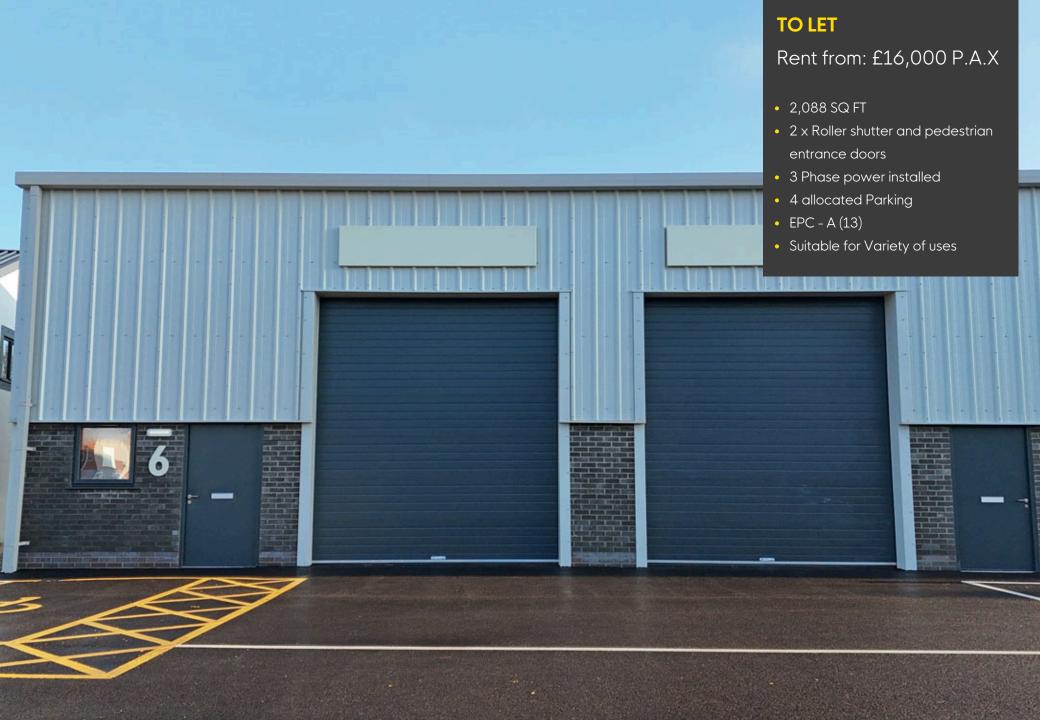
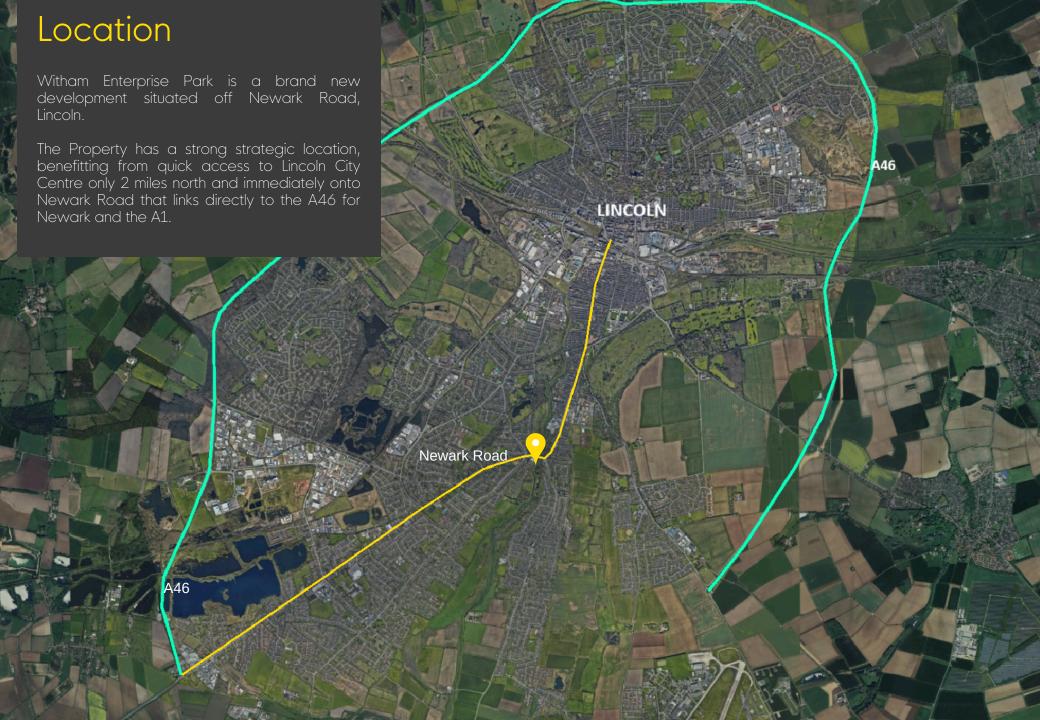

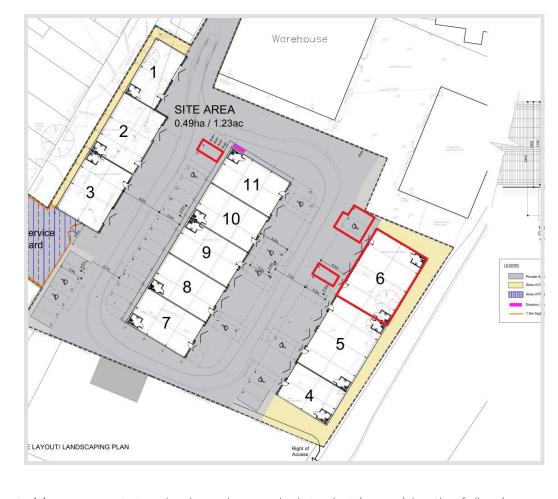


## Description

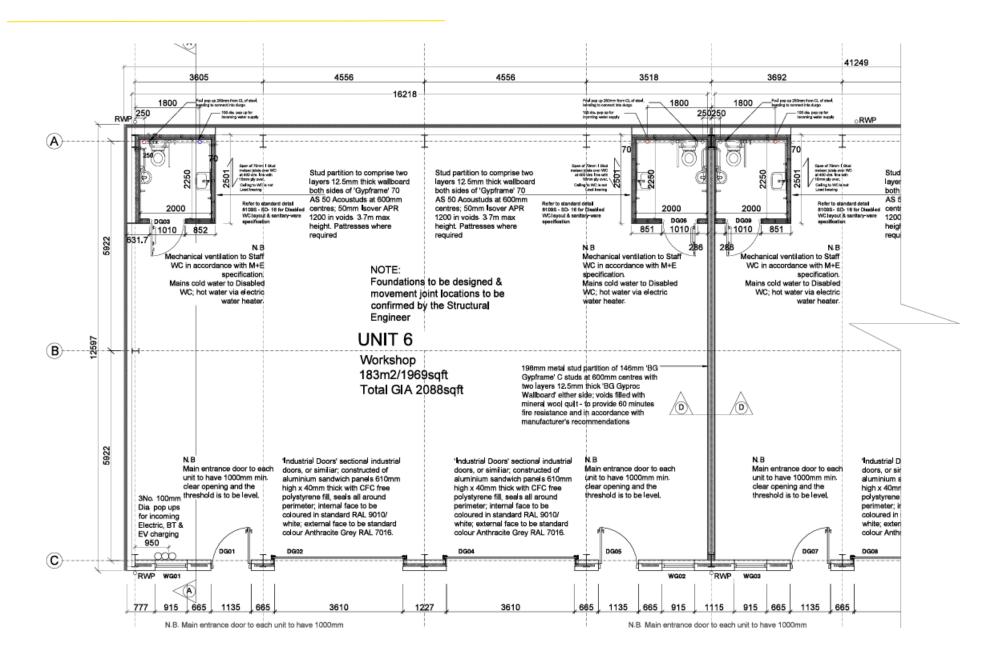
