- Access/escape route at the rear to Bridgewater Terrace

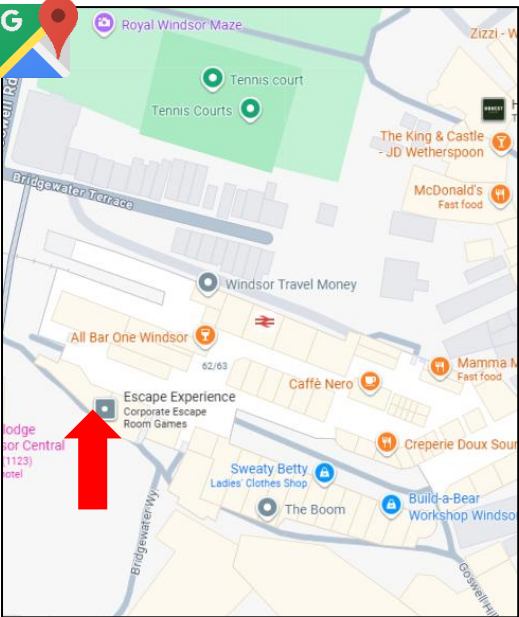

Description

Two fully refurbished arches of brick construction neighbouring Windsor & Eton Central Station. The arches are fully lined internally and suitable for a range of E class uses. Both arches are accessed through glazed frontages behind an electric roller shutter facing Goswell Hill.

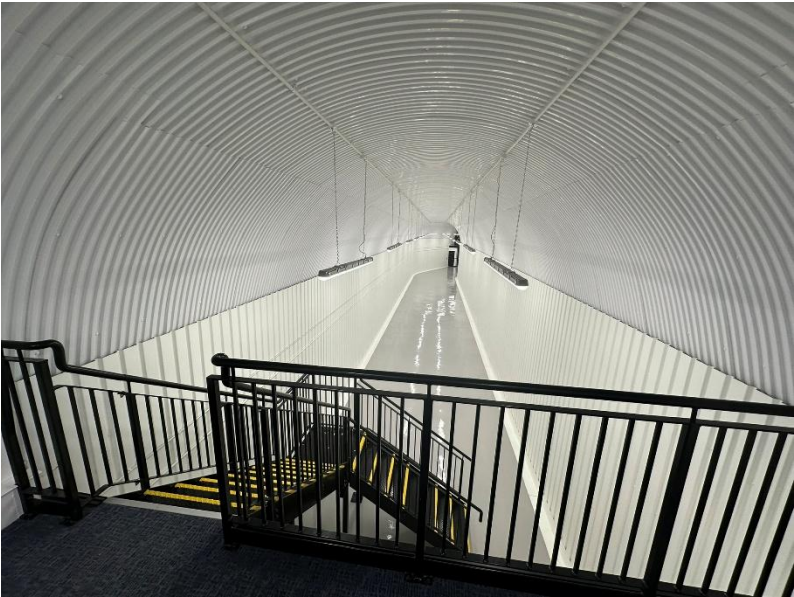
