

Opportunity Summary

- Rare opportunity to acquire a **prime urban logistics led development opportunity** in an ultra-urban location.
- ◆ Located in **South Bermondsey**, a key South London industrial hub.
- Prime arterial road (A2 Old Kent Road) and rail
 (South Bermondsey) connections combine with wider population growth to attract last mile logistics operators.
- Close proximity to the ongoing Elephant & Castle regeneration, with plans for a further 5,000 homes, as well as planned developments at Canada Water and along the Old Kent Road.
- Potential Bakerloo Line extension to provide new nearby underground stations.
- Total site area of 4.25 Acres (1.72 Hectares), with existing floor areas of circa 110,000 Sq Ft (containing urban logistics and a single office building).
- The estate is partially let, providing a current net income of £693,985 per annum.







Location

The Site is located at 14-16 Verney Road & Sandgate Industrial Estate (53-57 Sandgate Street) in South Bermondsey, just off the Old Kent Road (A2), providing excellent access to Central and South East London, as well as The City. The Site is strategically located with key arterial routes available nearby via the A2 and A20, as well as the M25 to the southeast (12.8 miles).

The immediate area is predominately industrial use, Line includes the Old Kent Road Station which, although it has been undergoing transformation, with a high rise residential and purpose-built student accommodation scheme being delivered

to the south of the Site on the land at Ruby Triangle. South Bermondsey is ideally positioned as a key industrial hub serving the capital, attracting a wide range of tenants including last mile logistics, dark kitchens and traditional industrial occupiers.

South Bermondsey station is a 10-minute walk and there are several bus stops serving the Old Kent Road. The planned extension of the Bakerloo when completed, would also be a 10-minute walk.

Description

The Site extends to 4.25 acres (1.72 HA) and comprises of three separate properties under four individual titles.

Sandgate Industrial Estate arranged as 11 industrial units around a communal yard, measuring 1.52 acres (0.62 ha) in total.

14-16 Verney Road – arranged as two warehouses, Unit 2 (also known as Unit A) which is let to a commercial tenant and Unit 3, which is vacant.

Action House – containing a three storey selfcontained office building that is let to a single commercial tenant (Artistic Spaces), who sublet and manage the workspace. Partitioned into small studio spaces, from 10 Sq M upwards.

The Site presents an industrial led development or refurbishment opportunity in an ultra-urban location with great connectivity.

The Site currently benefits from three access points, one off Verney Road to the north and two off Sandgate Street to the south.



Old Kent Road Area Action Plan (2024)



Planning

Southwark Council is currently in the process of adopting a new Area Action Plan for the Old Kent Road and surrounding area, following its designation as an opportunity area in the Local Plan (2022).

Regulation 19 public consultation on the Draft Old Kent Road Area Action Plan (AAP) took place February 2025 – April 2025. It is anticipated that the AAP will be adopted in late 2025, following an Examination in Public.

Within this draft plan the Site is located within Sub Area 3 - Sandgate Street, Verney Road and Old Kent Road (south). In line with Local Plan Policy NSP68, the masterplan for this Site is to transform the area into a new mixed-use location.

The draft AAP establishes that within Sub Area 3, there is development capacity for 5,300 homes, 2,661 jobs, 3 parks, 1 sports hall and 1 Primary School.

Additionally included within the AAP is an indicative typologies plan of Sub Area 3, which identifies the potential uses of the Site and the wider allocation. This is included in the map opposite, also illustrating the potential for stacked uses.

Local Plan Policy P30 - (office and business development) states that within site allocations where employment re-provision is required, development must:

- Retain or increase the amount of employment floorspace on site (Gross Internal Area (GIA) of E(g), B2, B8 class use or sui generis employment generating uses); and
- Promote the successful integration of homes and employment space in physical layout and servicing in areas that will accommodate mixed use development. This will include a range of employment spaces including freight, logistics, light industry, co-working, maker spaces and offices; and
- Provide a marketing strategy for the use and occupation of the employment space to be delivered to demonstrate how it will meet current market demand.
- Proposals for a new access road running through the Site (at the existing location of 14-16 Verney Road) have been considered from a planning perspective, with the existing access from Verney Road to be closed off. Plans for this will therefore need to be considered.

The regeneration of Elephant & Castle is one of London's most significant, helping transform the heart of Southwark into a more vibrant and sustainable town centre. With over £4 Billion spent to date, the regeneration includes new homes, public spaces, high quality retail, education and cultural facilities to transform the town centre into the cultural hub of South London.

The plans have been focused on the new town centre and Elephant Park which is nearing completion, however further proposals are also coming forward.

These will deliver over 5,000 additional new homes across multiple developments, as well as significant investment in infrastructure and public spaces, helping contribute to and accommodate for 10,000 new jobs for the area.

Situated 10 minutes by road from Elephant & Castle Station, the Site is ideally located to cater to the growing demand and contribute to Elephant & Castle's ongoing success.













Old Kent Road Regeneration

Old Kent Road is undergoing a significant programme of renewal which will transform the local area from Bricklayers Arms to

Proposals include a total of 20,000 homes, a doubling of jobs to 10,000, a revitalised high street with shopping and town centre facilities as well as two new tube stations.

Canada Water

In addition to Elephant and Castle and the Old Kent Road itself, over the next 15 years Canada Water is undergoing significant regeneration with 3,000 new homes, 1m Sq Ft of retail and leisure, and 2m Sq Ft smart enabled workspace – all located a six minutes by road from the Site.

This is being delivered by British Land in partnership with LB Southwark and funders.


Occupational Evidence

The London industrial market faces supply constraint issues, as a result supply-demand issues have driven up rents across the capital. Bermondsey is characterised by robust occupier demand and strong rental growth with little new build development in the area.

Ultra urban sites, such as Verney Road and Sandgate Street, present an opportunity to attract alternative as well as traditional occupiers. These alternative occupiers, such as dark kitchens and rapid delivery outlets, including Deliveroo and Karma Kitchens, prioritise proximity to the end consumer above all else. Recent evidence places prime new build rents in excess of £40 per Sq Ft.
