Description

The arches, which are internally connected, are fully lined, of brick construction, and suitable for B8 storage uses or a variety of alternative uses subject to planning.

Access to the units is from Glasshouse Walk only via the electric roller shutter door. Internally the space benefits from 3-phase power, strip lighting, water, drainage soil stack and a concrete floor. A fire escape corridor provides means of escape out towards Tinworth Street. The height to the crown of the arch is approximately 4m.

The arches are located on Glasshouse Walk in close to proximity to Vauxhall Pleasure Gardens. The arches are situated between Goding Street and Albert Embankment. Glasshouse Walk is a 3-minute walk from Vauxhall Station (National Rail services), Vauxhall underground station (Victoria Line) and Vauxhall bus station.

Albert Embankment and Goding Street, adjacent, includes occupiers such as Mother Kelly's Tap Room, Majestic Wine, Casa Madeira, Pico Bar, Sleven Fitness, Ducati, Triumph, KTM, London Space Elevator, amongst others. Closer to the station we have Nando's, Lakeland Climbing and Market Place Vauxhall.
