### Location

The West Yorkshire city of Wakefield is located approximately 8 miles to the south of Leeds, 45 miles north of Sheffield and 20 miles to the north west of Doncaster. The city benefits from an estimated population of 353,400 (2021 census).

The property is located to the south of the city centre on Ings Road (A638) which is effectively the City's inner ring road and one of the busiest in the area.

Wakefield's principle out of town retailing provision is located along Ings Road on the Beck Retail Park, Cathedral Retail Park, Westgate and Albion Mills. Additionally, there are a number of stand alone trade and retail units in the immediate vicinity.

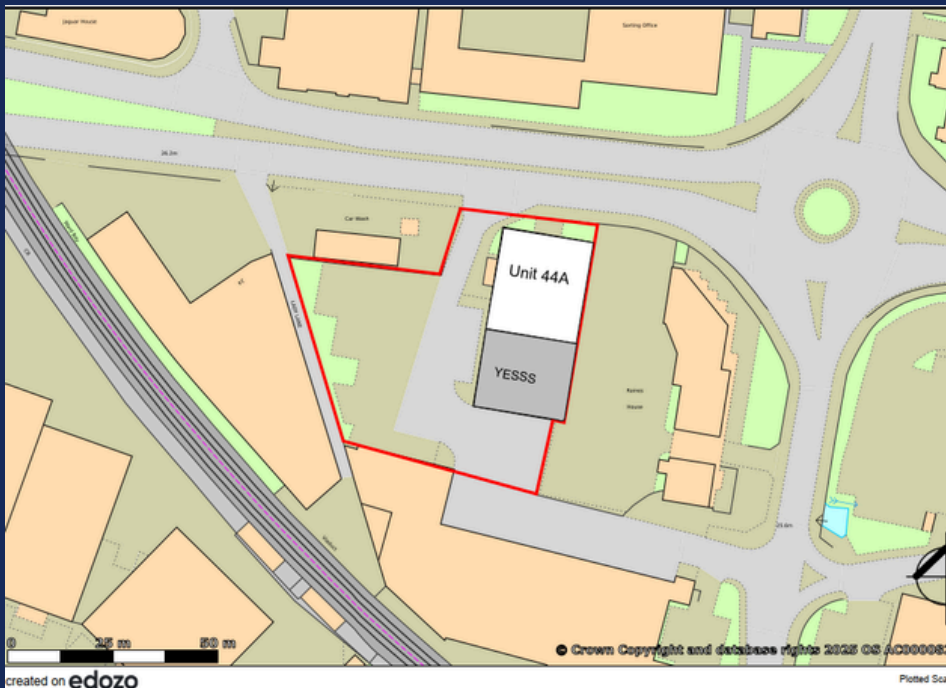
## Description

The property is a single story retail warehouse, predominantly open plan with a storage area/service bay, office and staff toilet.

## Rateable Value

The rateable value of the property from 1<sup>st</sup> April 2026 will be £46,250 pa.

The retail warehouse will be available on a new full repairing and insuring lease for a minimum term of 10 years. The initial rent to be £61,600 per annum.

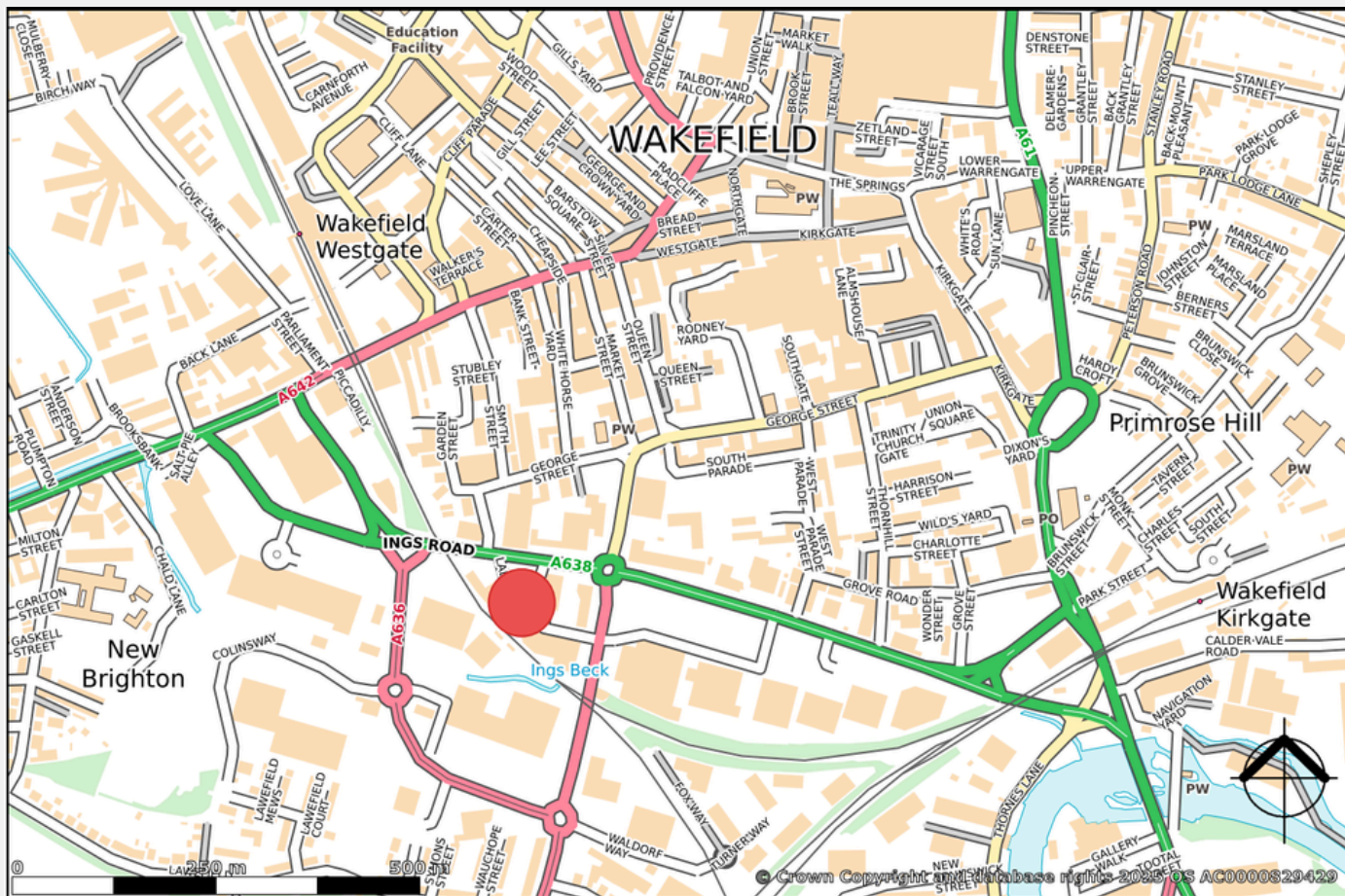
## Freehold/Part Investment
