### Location

The site is located on the popular Ten Pound Walk area of Doncaster which is accessed from White Rose Way and has fantastic road linkage to Junction 3 of the M18, 1.5 miles away, leading onto A1, M180, M1 and M62. The area is popular with logistics and rail occupiers including Volker Rail and Network Rail.



# **Description**

The site has a 1332 sq ft workshop with 6661 sq ft of office space within 0.9 acres of hard surfaced parking/storage. The workshop comprises of a roller shutter door which is linked to a two storey office block. With differing sizes of office and meeting rooms. There is ample parking within a secure yard. The property would suit a range of uses with neighbouring tenants such as Hitachi Rail, Tesco, Volker Rail, B&Q and Network Rail.
