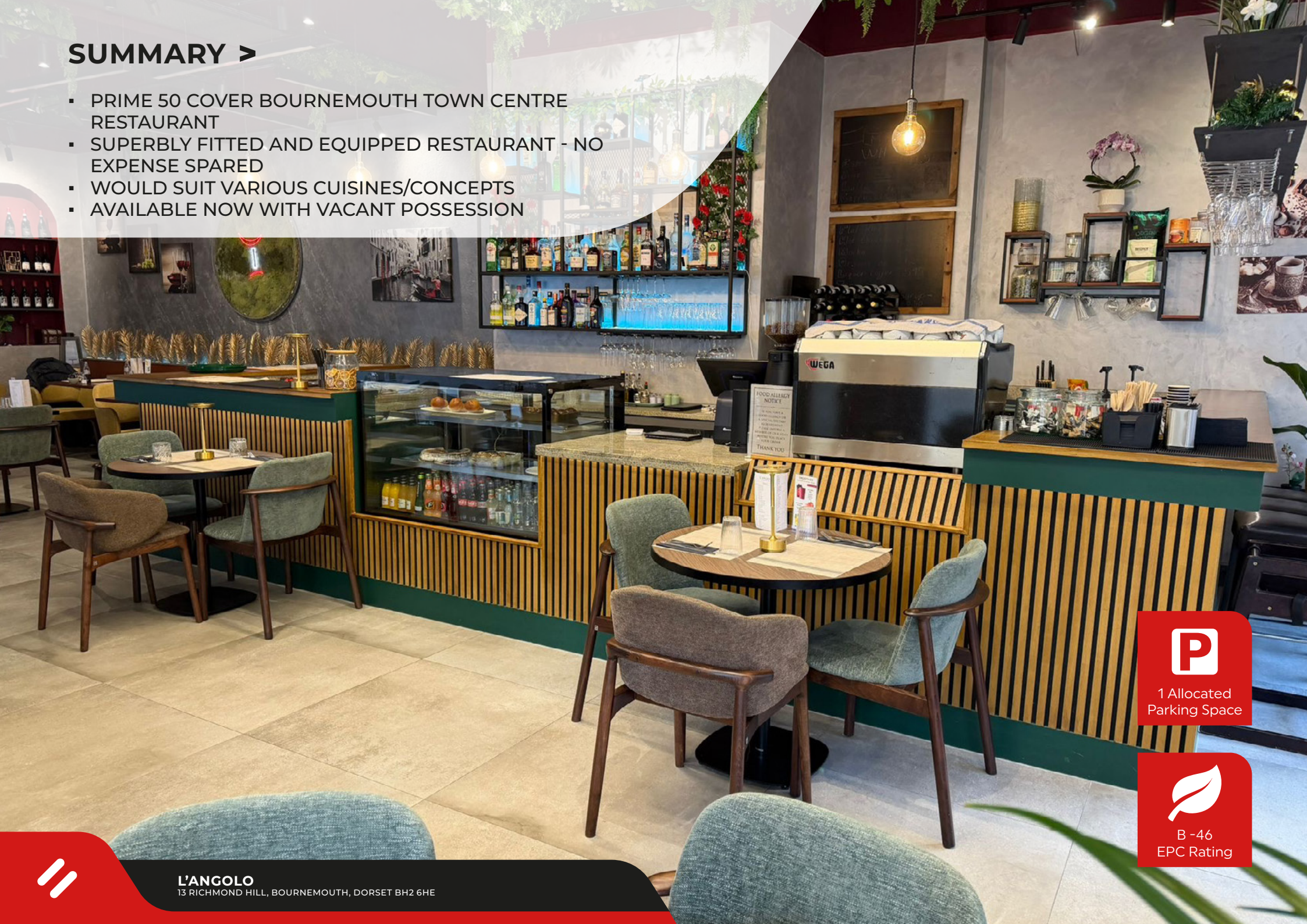

## Location

Superb highly prominent corner location in Bournemouth Town Centre. Approx. 87 yards from Bournemouth Square. Located amidst shops, businesses and residential accommodation.

## Accommodation

Restaurant (50 covers). Basement. Ladies & Gents Cloakrooms. Walk in Store Room. Kitchen.

## Description

Through door into **Lobby** with burglar alarm and fire alarm panels, tiled floor. Through door into **Restaurant** with tiled floor, upholstered wooden framed chairs and wood affect laminated topped tables with metal bases for approximately 50 covers, Mitsubishi ceiling mounted air conditioning unit, wall mounted speakers, wall mounted flat screen television, feature ceiling spotlights and low level lighting, wooden counter/bar servery, laminated floor, shelving, natural stone work top surfaces, ice machine, glass washer, hi-fi system, smoothie blender, ice dump, 2 double chiller displays, Wega coffee machine and coffee grinder, coffee tamper, double glass fronted chiller display, cocktail bar, deep bowl stainless steel sink unit, stainless steel wash up. Stairs from Restaurant down into **BASEMENT** with Infonet mirror with LED frame, tiled floor, built in wine cooler, CCTV throughout. Through into **Cloakroom** with wash hand basin, 3 electric hand dryers, tiled walls. **Ladies Cloakroom** with fully tiled walls and floor, wash hand basin, electric hand dryer, cubicle with low level WC, baby changing area, touch lit mirror, extraction fan. **Gents Cloakroom** with tiled walls and floor, wash hand basin, wall mounted electric hand dryer, touch lit mirror, extraction fan. Through into **Walk in Store Room** with shelving, counter fridge. Door into **Lobby** with storage, stairs down into Basement with access to car park. **Kitchen** with non slip commercial floor, wash hand basin, shelving, upright fridge, deep bowl single drainer stainless steel sink unit, dishwasher, chiller 3 cupboard freezer. 3 cupboard fridge, extraction system above, 2 hob Adexa range, double deep fat fryer, Rational oven, commercial grill, microwave, air conditioning system, shelving. **OUTSIDE** To the rear of the property there is car parking for 1 vehicle.

## Trading & Business

The premises are being offered fully fitted and equipped with vacant possession. The business closed in March 2026.

## Licences/Permissions

We are informed that the property holds a Premises Licence granted by BCP Council (Bournemouth). The Premises Licence operates until 12.00 midnight 7 days a week. The Licensing Act 2003 states that properties serving alcohol have a designated premises supervisor who must hold a Personal Licence. We suggest that all purchasers take appropriate professional advice. We have not had sight of this licensing documentation.

## Tenure

LEASEHOLD. The premises are held under an original 15 year lease from 2024, with 3 year rent reviews, at a current rent of £31,500 per annum. We have not had sight of this lease documentation.
