Location

Chipping Warden Barns are situated at the Manor Farm Business Park, adjacent to a barn-conversion office scheme and the 600,000 sq ft Appletree Trading Estate, just outside the village of Chipping Warden, along the A361 and with easy access to Junction 11 of the M40 (Banbury – 6 miles) and just 11 miles from Daventry in Northants, which in turn provides good access to the M1 and the UK's wider national motorway network.

Description

This self-contained 1-acre site comprises three industrial/storage units of steel portal frame construction totalling 15,609 sq ft, offered together with large and secure yard to both the front and rear.

Unit A benefits from 2 roller shutter doors and LED lighting. Unit 1 has a height to eaves of 5.2 meters.

Unit B&C has two roller shutter doors to front and one further shutter door providing access to the rear yard. A surface water gully has been installed connecting the two former buildings together. Unit B has a height to eaves of 3.9m

Unit B&C also benefits from quality office accommodation to ground and first floors, with 3x WC's, a kitchenette, boardroom and storage rooms. Air conditioning to offices has also been provided. Imagery is available upon request.

Unit D is situated behind Unit 2 within the rear yard area; a modern storage building with a concrete floor and a height to eaves of 4.75m.

As will be seen on the aerial imagery, there is good car parking together with ample loading/unloading to both front and rear (rear yard has been hard-cored).

Services

A three-phase power connection is provided, excluding water, mains drainage and gas. None of the above services have been tested by the agents.
