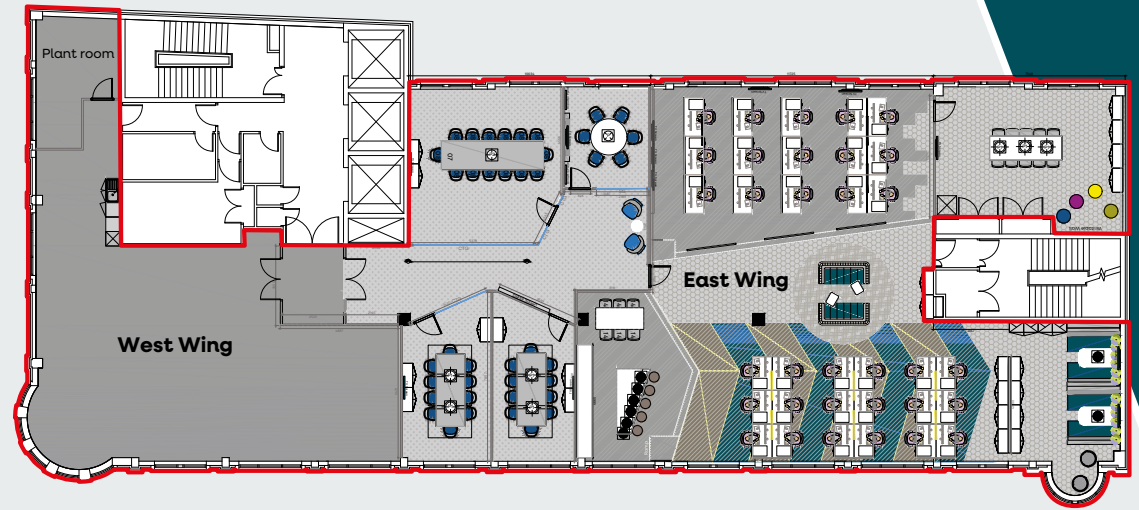

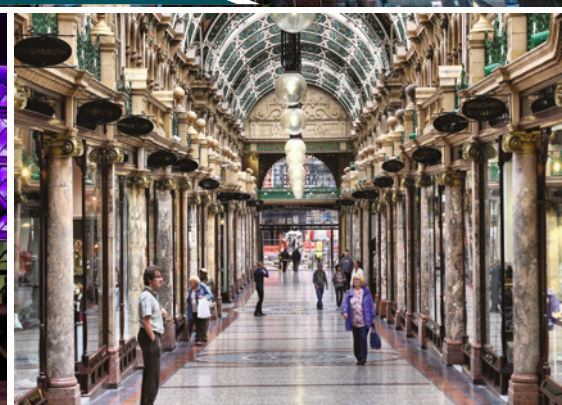
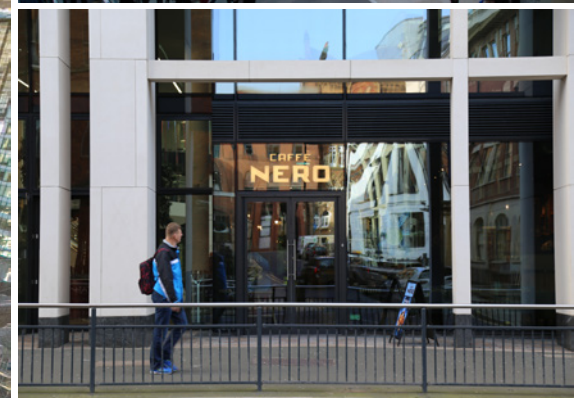
FIFTH FLOOR SPACE PLAN
