

Description

The detached property is of steel portal frame construction with brick and profiled steel clad elevations under a profile metal sheet roof with integrated roof lights. The unit benefits from a self contained secure loading area and generous car parking. Internally, the unit has an eaves height of 6.8m, rising to and apex of 8.3m, and first floor office accommodation incorporating welfare facilities.

The property benefits from 3-phase electricity, mains water and drainage.

Location

The property is situated on Alexandra Way as part of Ashchurch Business Centre, an established industrial and logistics location. The site benefits from excellent motorway access (0.5 miles) via J.9 of the M5 and onward access to the Midlands via the A46 trunk road.
