## Location

The Land is situated on Dick Turpin Way, which is just off the Great Southern Western Heathrow Perimeter Road, and Heathrow airport. Hatton Cross Underground station (Piccadilly Line) is circa. 0.25 miles north, and Heathrow airport itself, is circa. 0.3 miles north: A312 Causeway is circa. 0.1 mile to the south.

Local amenities include a Tesco Superstore within circa 0.5 miles to the south, Hilton Gardens Inn Hotel to the north, and the Green Man Public House, circa. 300 yards to the east.

## Property

The site which is fenced and gated, has a mix of ex-farm buildings, some being open-sided and some fully enclosed. Farm buildings total 3,487 sq. ft of buildings and the site benefits from hardstanding space.
