Description

The property comprises of first floor office space which benefits from air conditioning, its own kitchen and toilet facilities which include a shower. The offices benefit from a suspended ceiling and excellent natural daylight supplemented by LED lighting. The space contains 3 glass partitioned meeting rooms as well as a storage area to the rear.

Location

The property is situated close to the junction of South Road and East Road. It is conveniently situated close to the retail and trade parks on Edinburgh Way where occupiers include Tesco, Subway, Costa Coffee, Travis Perkins and Howdens Joinery.

Harlow Mill Station is within easy walking distance and offers a regular service to London Liverpool Street via Tottenham Hale (Victoria Line) to the South, and Stansted International Airport and Cambridge to the North. Numerous bus routes serving the outlying districts are available from Edinburgh Way. Junction 7 of the M11 is c.4 miles away and intersects with the M25 at Junction 27, c.5 miles to the South.
