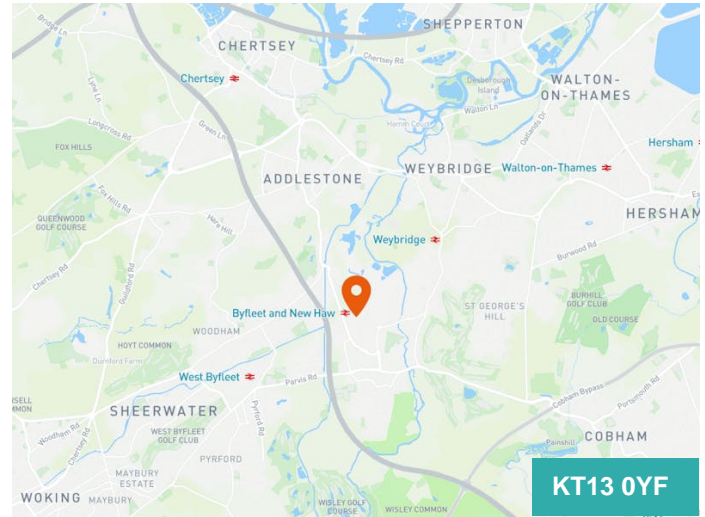

Description

Units 3 & 4 are offered as a single demise of high quality warehouse space with 12 car parking spaces. The warehouse design is a 50:50 warehouse - office split, making it the ideal opportunity for occupiers requiring both functional and admin space. The space is to be fully refurbished prior to the tenant's occupation. The units comprise a total split of 3,121 sq ft warehouse space and 2,969 sq ft of 1st floor office. Preference is to let the units as a whole, but there is the option to let as two individual units.

Location

The property is on Trade City, located within the Brooklands Trading Estate, a major industrial hub within the South East.

It is well located being just 10 minutes from the A3 and J10 of the M25, providing strong travel connection into London, the South Coast, and up the M25 towards Heathrow. Major nearby towns include Weybridge, Addlestone, Woking and Staines.
