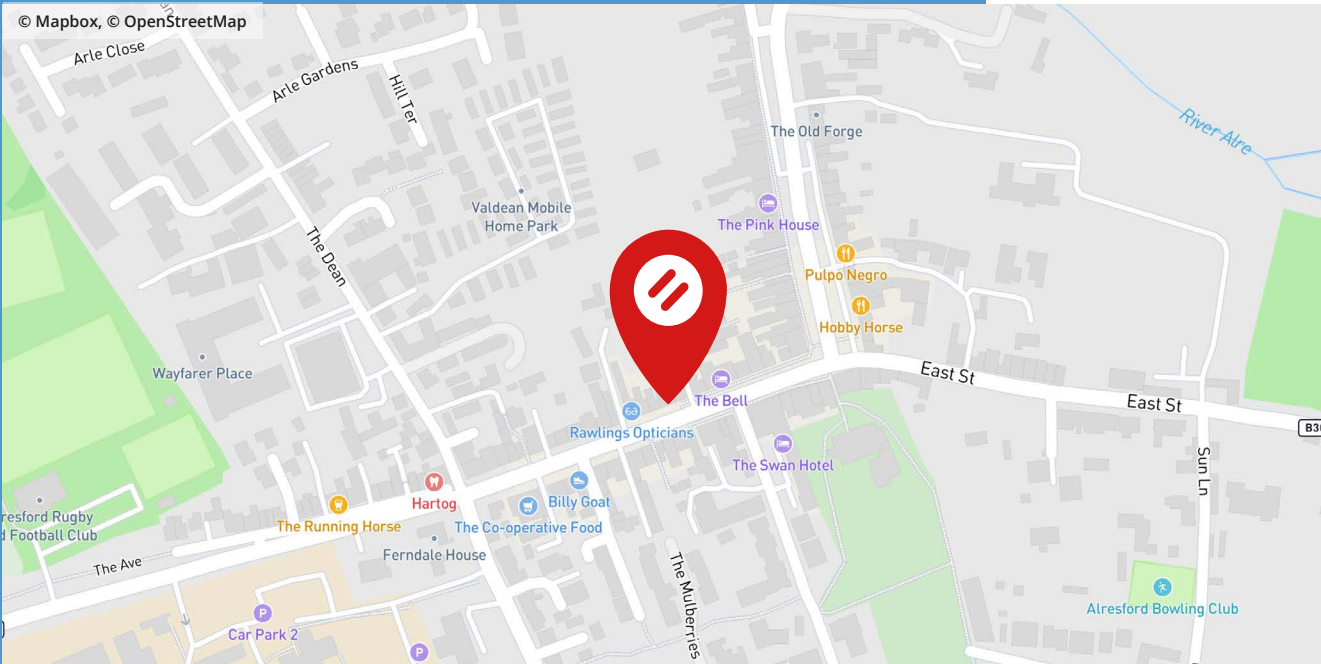

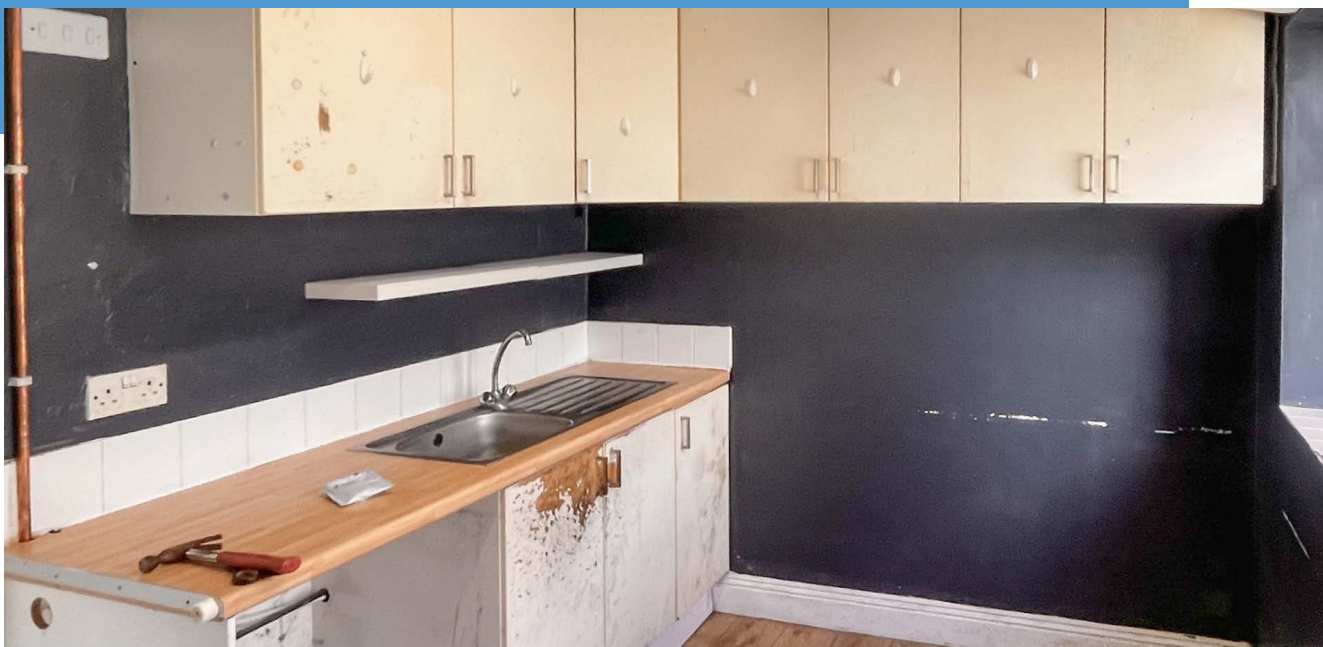
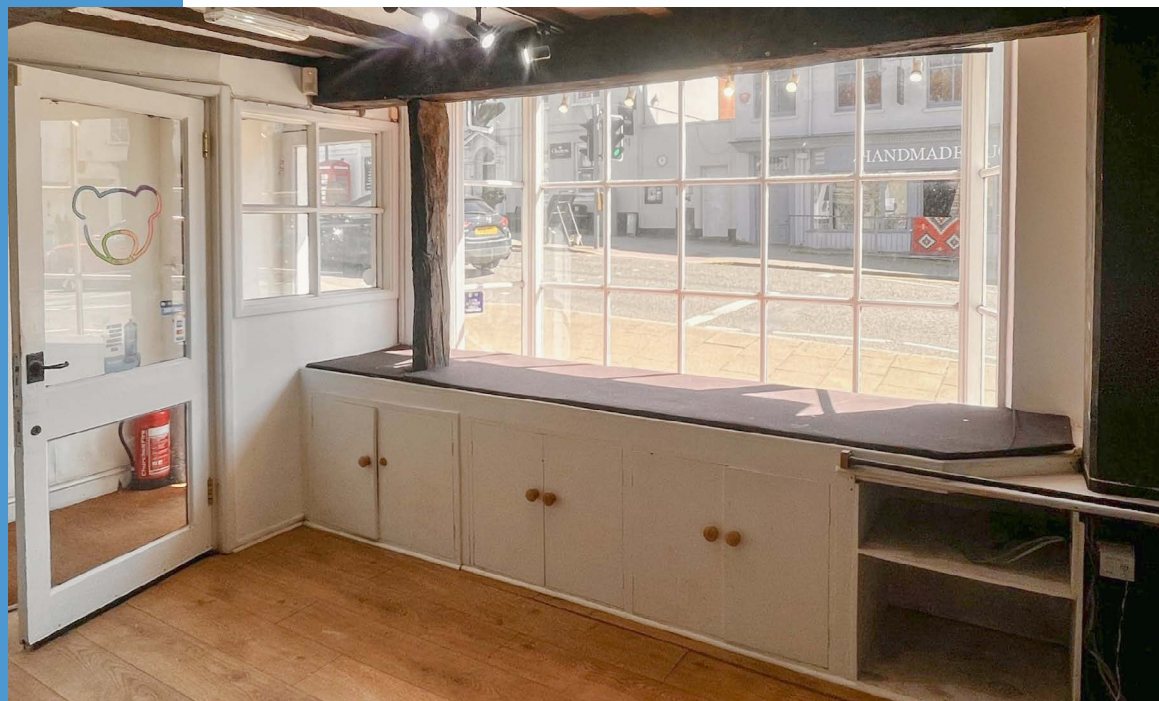
Location
