Description

Currently arranged as a kitchen showroom with retail, office and warehouse/storage space, this high-spec premises offers excellent versatility. Originally two separate units, it has been seamlessly combined to create one generous, adaptable space. Accessed via a private entrance to Unit 3, the property opens into a welcoming entrance hall leading to a reception/office area with a fully glazed frontage. The frontage benefits from a roller shutter and can be reverted to a full roller-shutter façade if required. The rear section of the unit is currently configured as office accommodation, while stairs from the entrance hall lead to additional showroom areas on both sides of the upper level. The property will be cleared of the existing showroom fit-out and made available as a vacant shell, ready for a new occupier's bespoke configuration. The warehouse/storage section is accessed via a private access door from Unit 4 this offers, excellent open plan storage with WC facilities

Located in Low Bentham, on Low Mills off Mill Lane, in a peaceful riverside location, Low Bentham village sits next to its sister town of High Bentham on the edge of the North Yorkshire Dales, with neighbouring towns and villages including Tunstall and Kirkby Lonsdale.


