Location

The property is situated in Bromsgrove, to the south of the town centre on Aston Fields Industrial Estate. Bromsgrove is a busy Worcestershire market town with easy access to the motorway network with Junctions 4 and 5 of the M5 motorway and Junction 1 of the M42 motorway being within three miles of the property, giving access to the Midlands motorway network.

Birmingham City Centre is situated approximately 13 miles to the north and Worcester City Centre is situated approximately 12 miles to the south.

Aston Fields Industrial Estate benefits from communal landscaping, allocated & communal parking and extensive security, including CCTV and security gates.

Description

Units 15 & 16 Aston Fields Industrial Estate comprises a mid-terrace commercial property of steel frame construction with brick & block elevations. The building is currently configured as a warehouse / industrial property, that has previously been used as a trade counter.

Internally, there is a good-sized warehouse area with the benefit of 4.75m eaves. Located to the front of the unit is a separate office area and WCs – offering male & female. The property is accessed via a pedestrian doors and roller shutter doors. Externally there are six car parking spaces with loading / unloading facilities to the front of the access door.

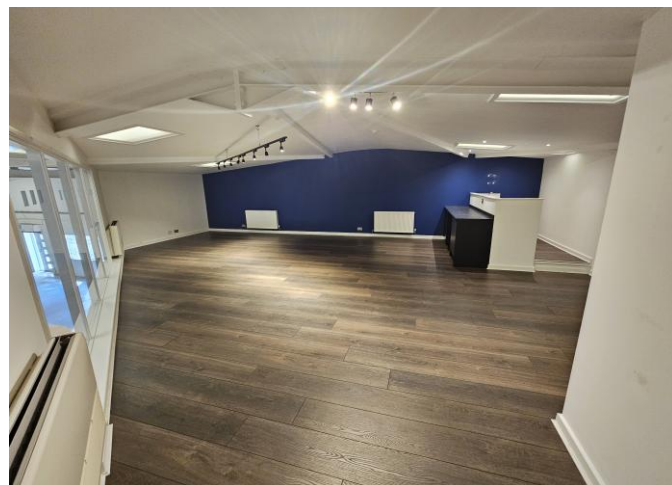
