








## Contemporary culture -A vibrant eclectic scene with many bars, cafés, restaurants & pubs close by



The building shares a party wall with the Clergy House, the covenant at the church, which has been restored and incorporated into the design of the building, joining it intrinsically with the rich architectural history of the building.


