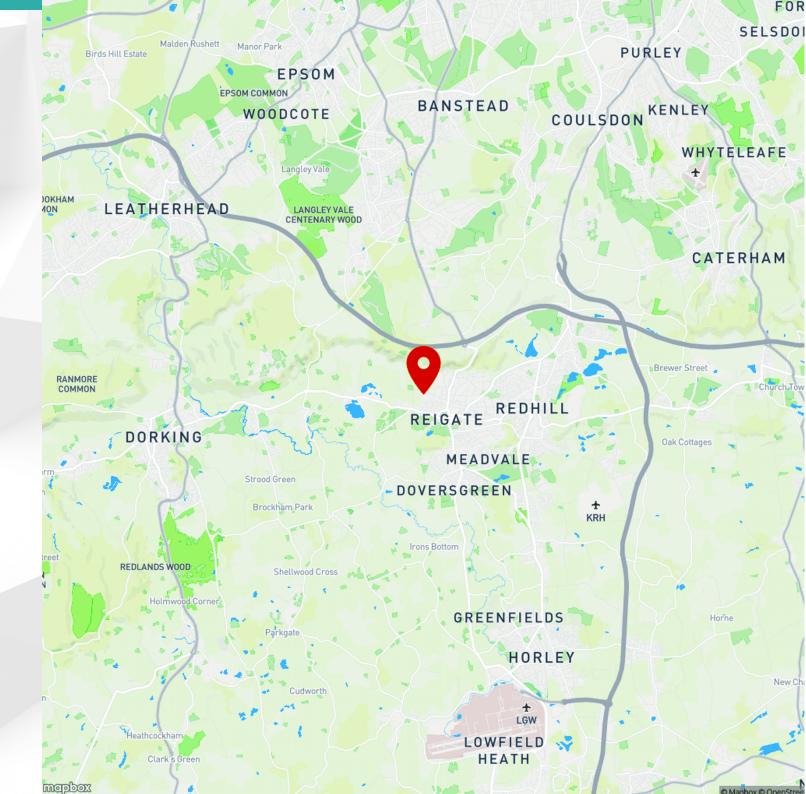
### Location



This property is located to the rear of the established Albert Road North Estate a few hundred meters north west of the centre of the historic market town of Reigate.

Access to the estate is via residential roads from the A217 London Road to the east and the A25 to the south. Via the A217, junction 8 of the M25 lies approximately 0.9 miles to the north and Gatwick Airport, approximately 7.5 miles to the south.

Reigate Railway Station is within 0.4 miles / 15 minutes walk to the east.

### **Description**

The property comprises a self-contained single storey concrete portal framed building with main open plan warehouse/industrial area with a roller shutter door entrance and separate pedestrian entrance to offices. Newly constructed high specification offices are located over two floors along the southern section and provide mix of open plan and meeting/board rooms. Well presented WC, kitchen and shower facilities are installed.

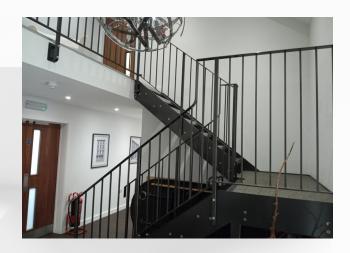
The building is currently separated using electronic key card doors providing independent offices from the warehouse zone. Loading and allocated 9 parking spaces are within a shared yard.

The entire building was reroofed with modern insulated cladding containing daylight panels in the latter part of 2022.
