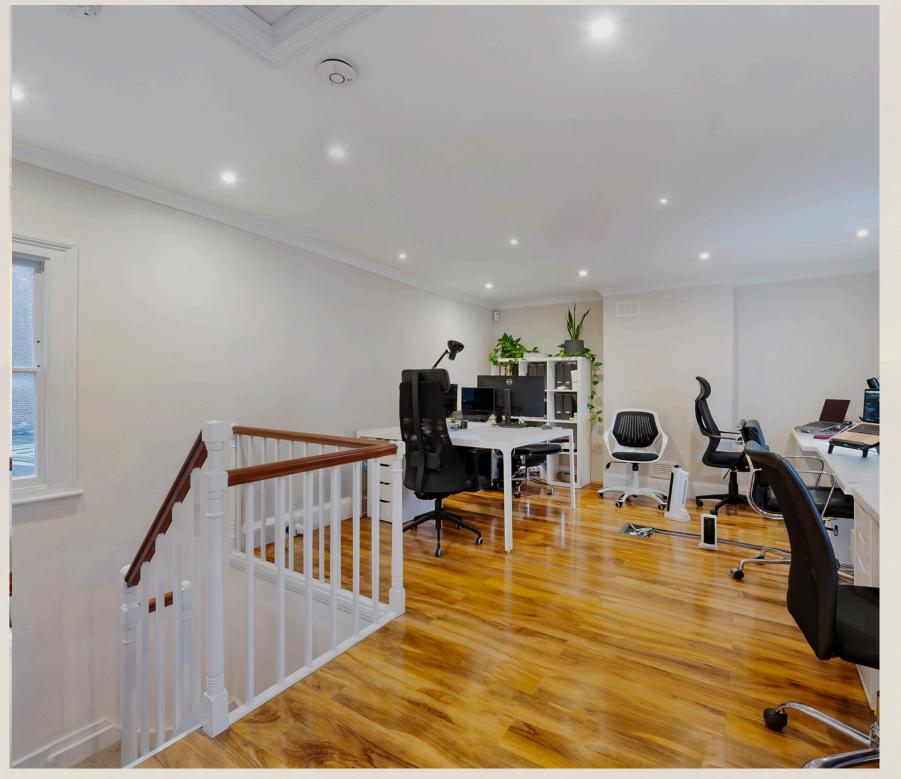
This self-contained townhouse style office is arrange over ground and first floor.

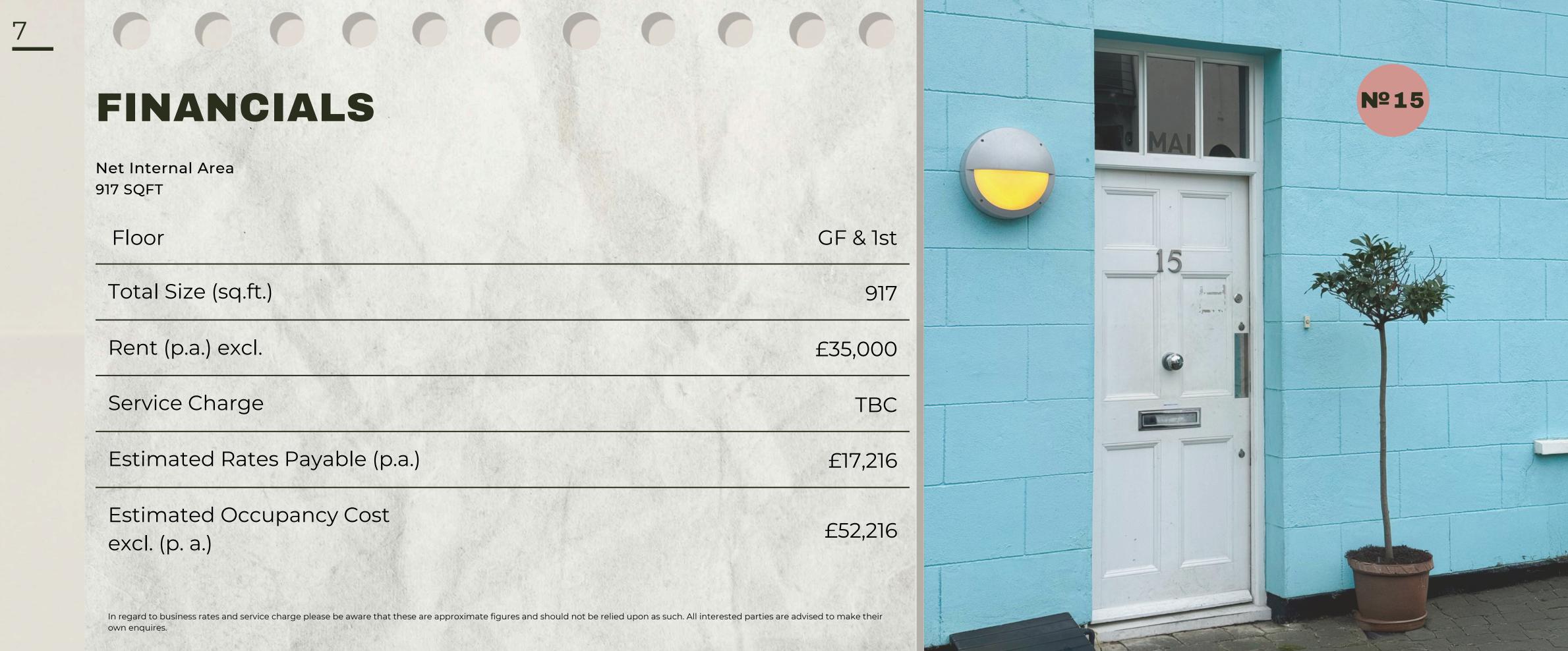
