LOCATION:

New Craigie Retail Park is directly accessed from Kingsway East, Dundee's outer ring road for seamless access to major routes including the A90 towards Perth, Edinburgh and Glasgow to the west, and Aberdeen to the north.

The subjects form part of a wider retail hub of strong footfall with Kingsway East Retail Park accommodating ASDA, B&M, Pets at Home, Home Bargains, McDonald's and KFC.

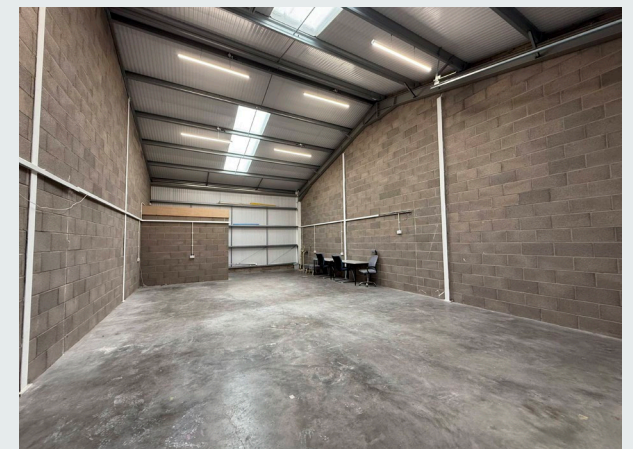
Unit 8 is located within a modern mixed use and trade counter location with neighbouring occupiers including Lidl, Screwfix, Arnold Clark, Tim Hortons, Collinson Ceramics and Window Supply Company.

DESCRIPTION:

The subjects comprise a mid-terraced industrial unit as part of a modern parade of workshop / trade counter premises. These units are of steel portal frame construction with high-quality profiled metal cladding.

Internally, Unit 8 benefits from an electrically operated roller shutter door, three phase power supply and a maximum eaves height of 5.82m arranged over a durable concrete floor. This is an open plan workshop with a WC facility to the rear.

The property also benefits from a shared surfaced front yard and delineated parking.

ACCOMMODATION & FLOOR AREAS :

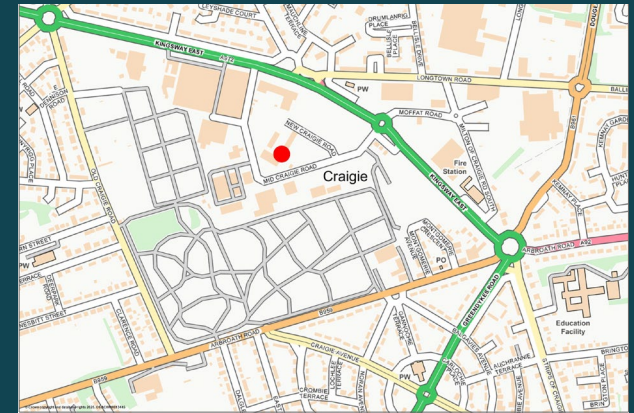
