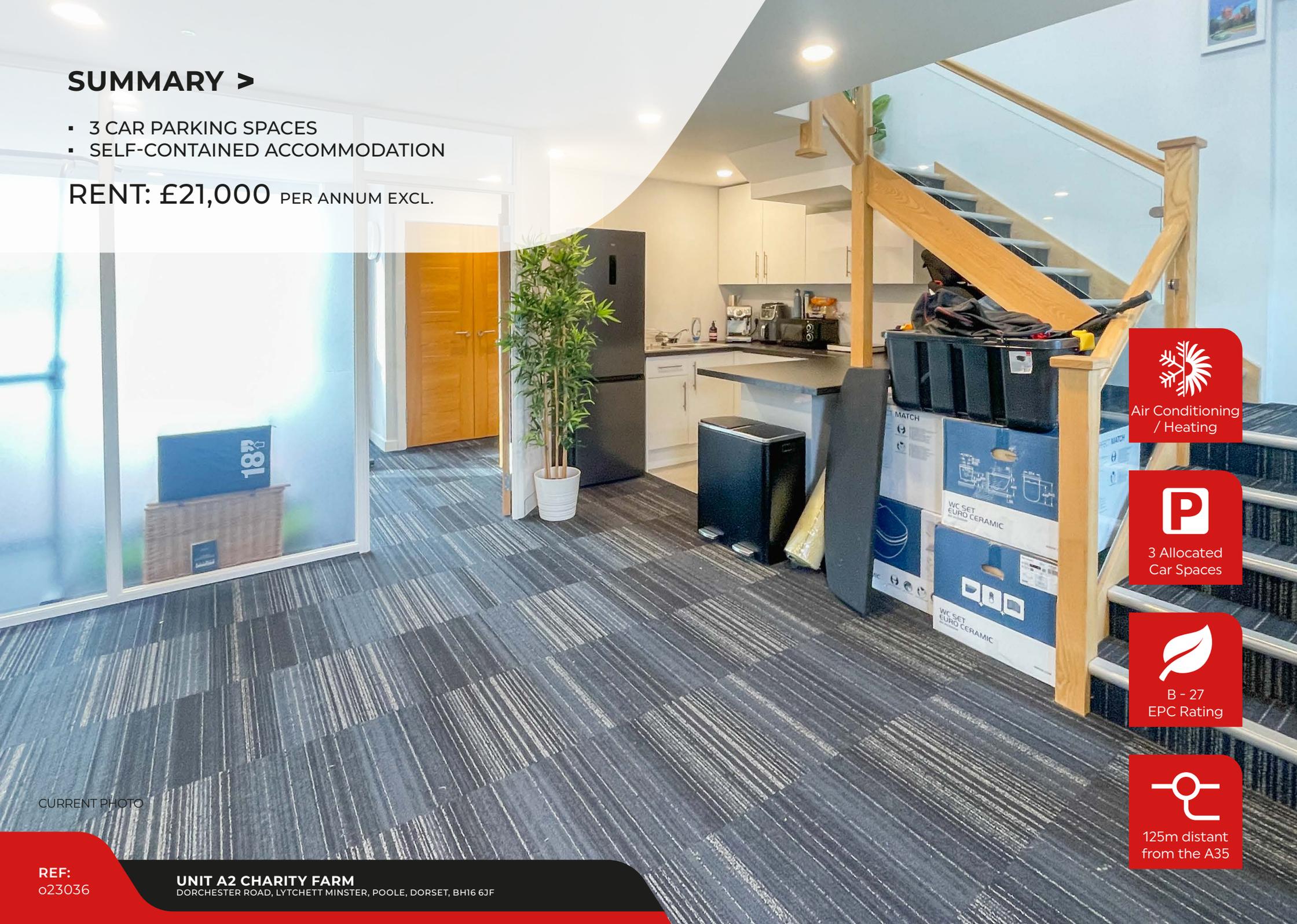

Charity Farm is located on Dorchester Road approximately 125m distant from the Bakers Arms Roundabout junction on the A35. 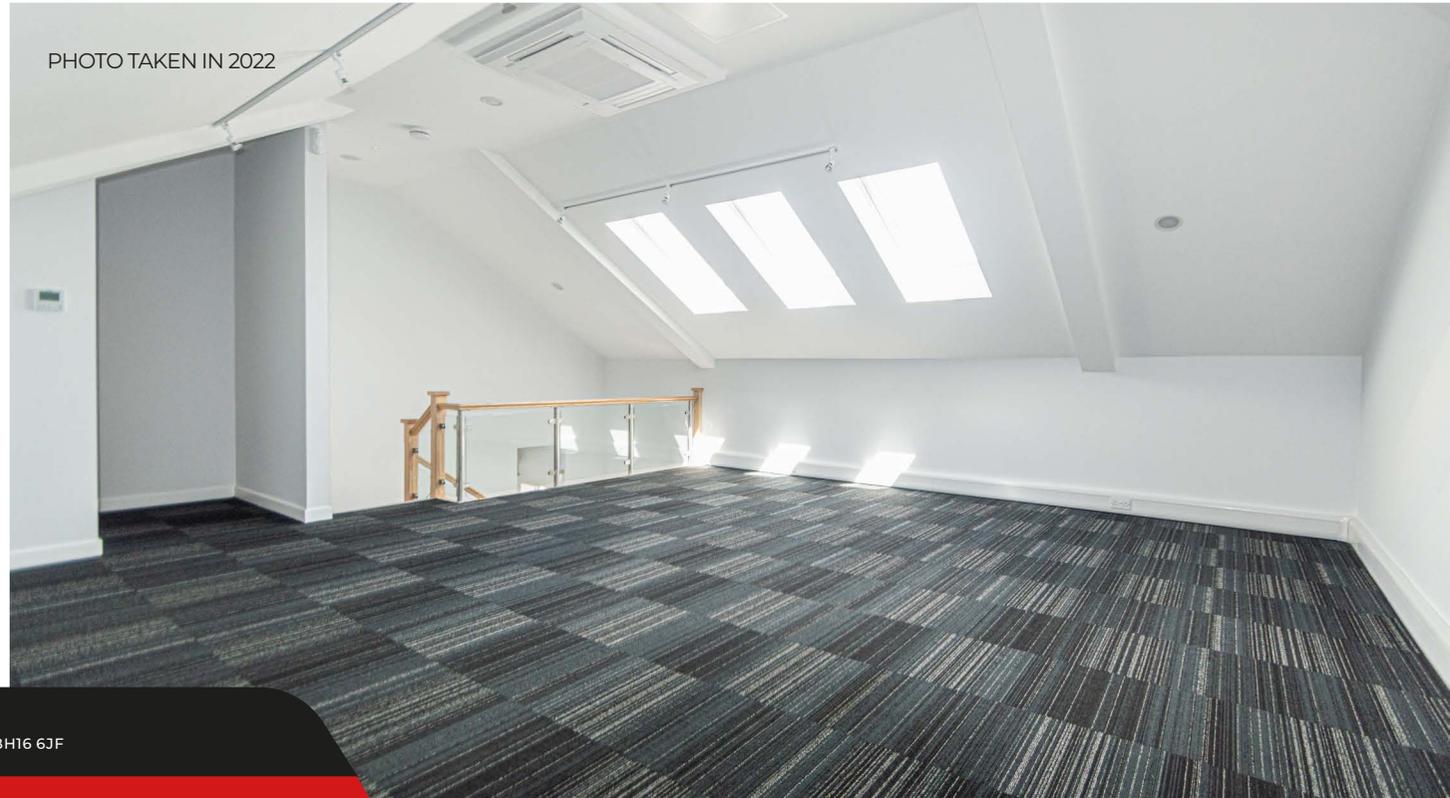
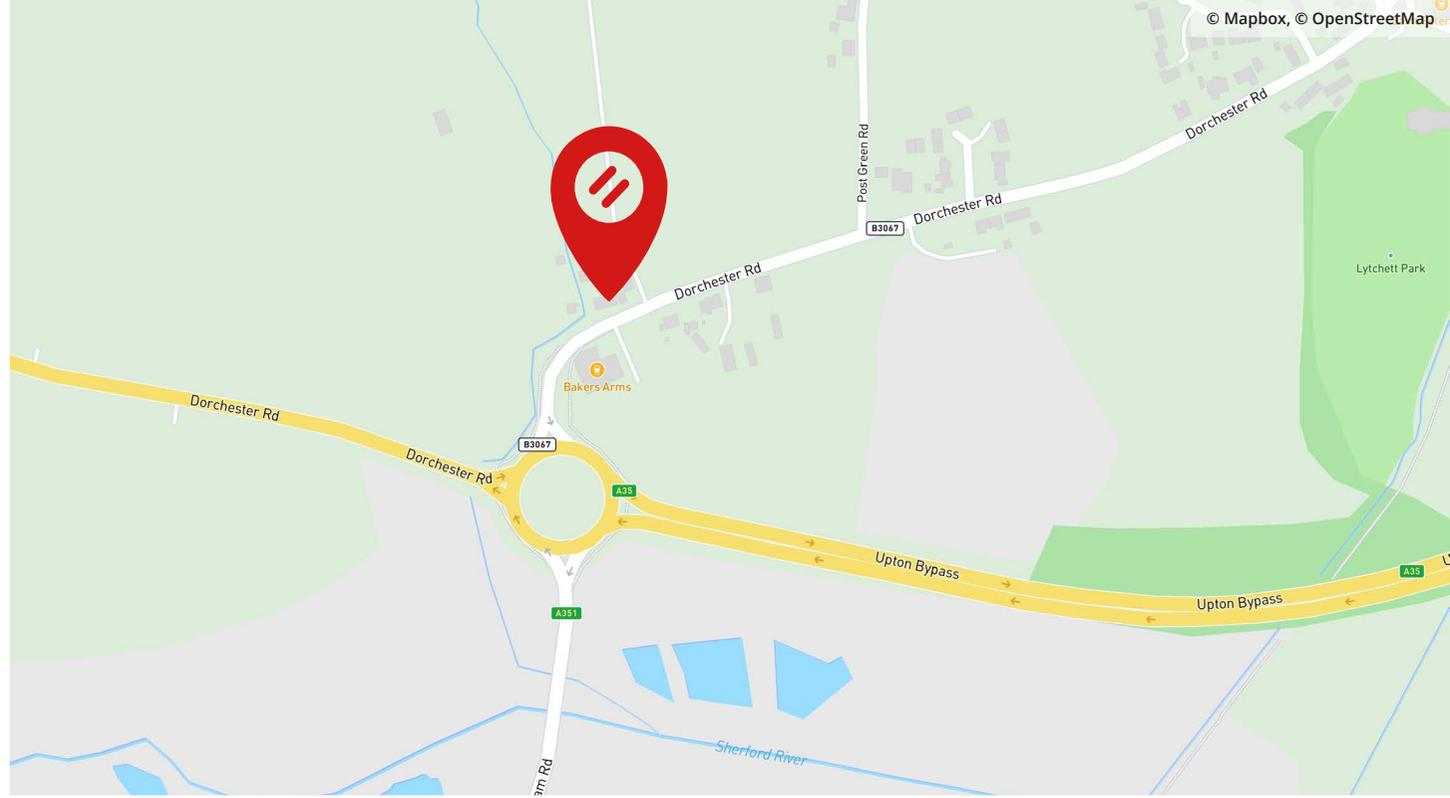
