This is an excellent opportunity for an incoming tenant to create a first class office space.

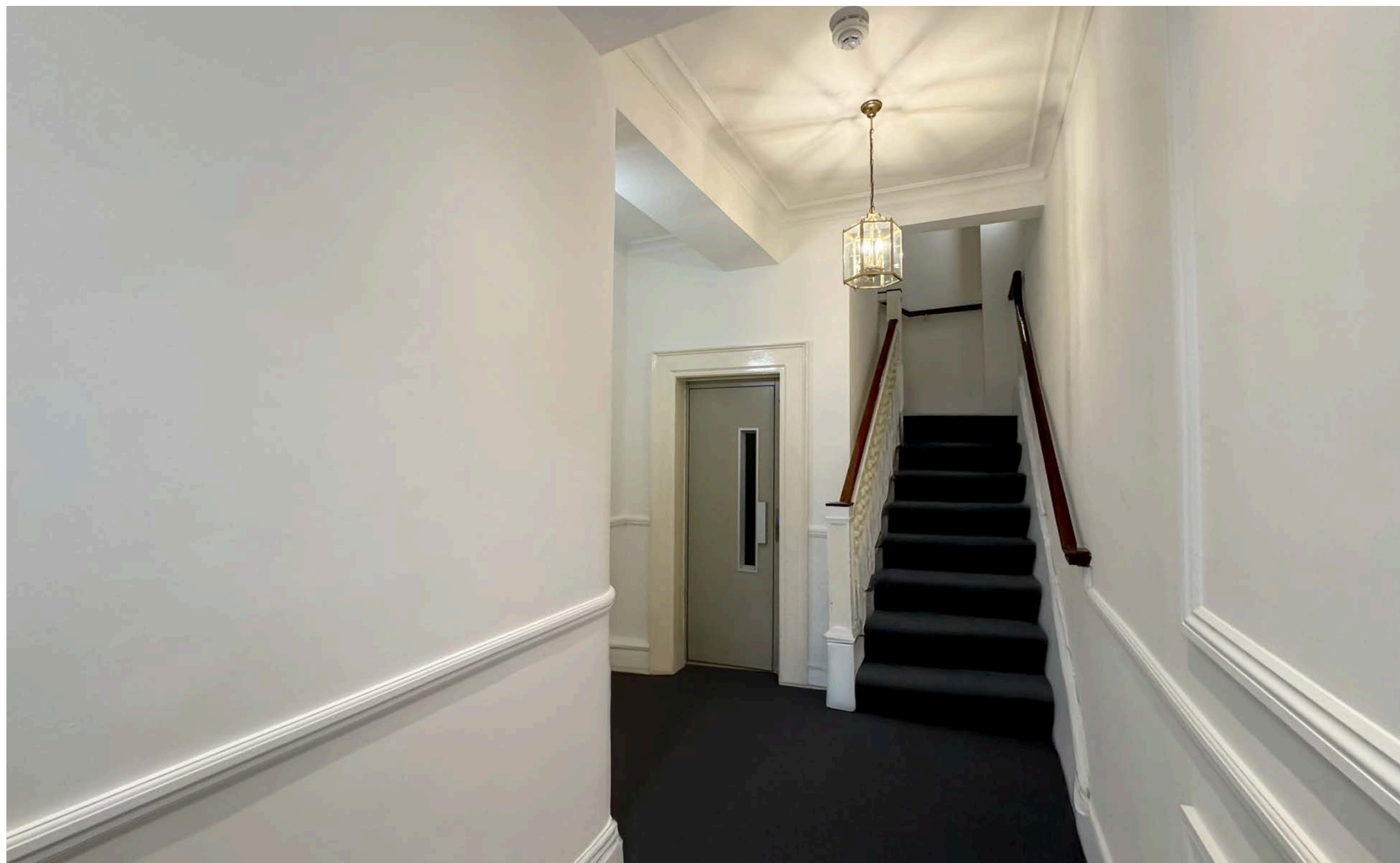
