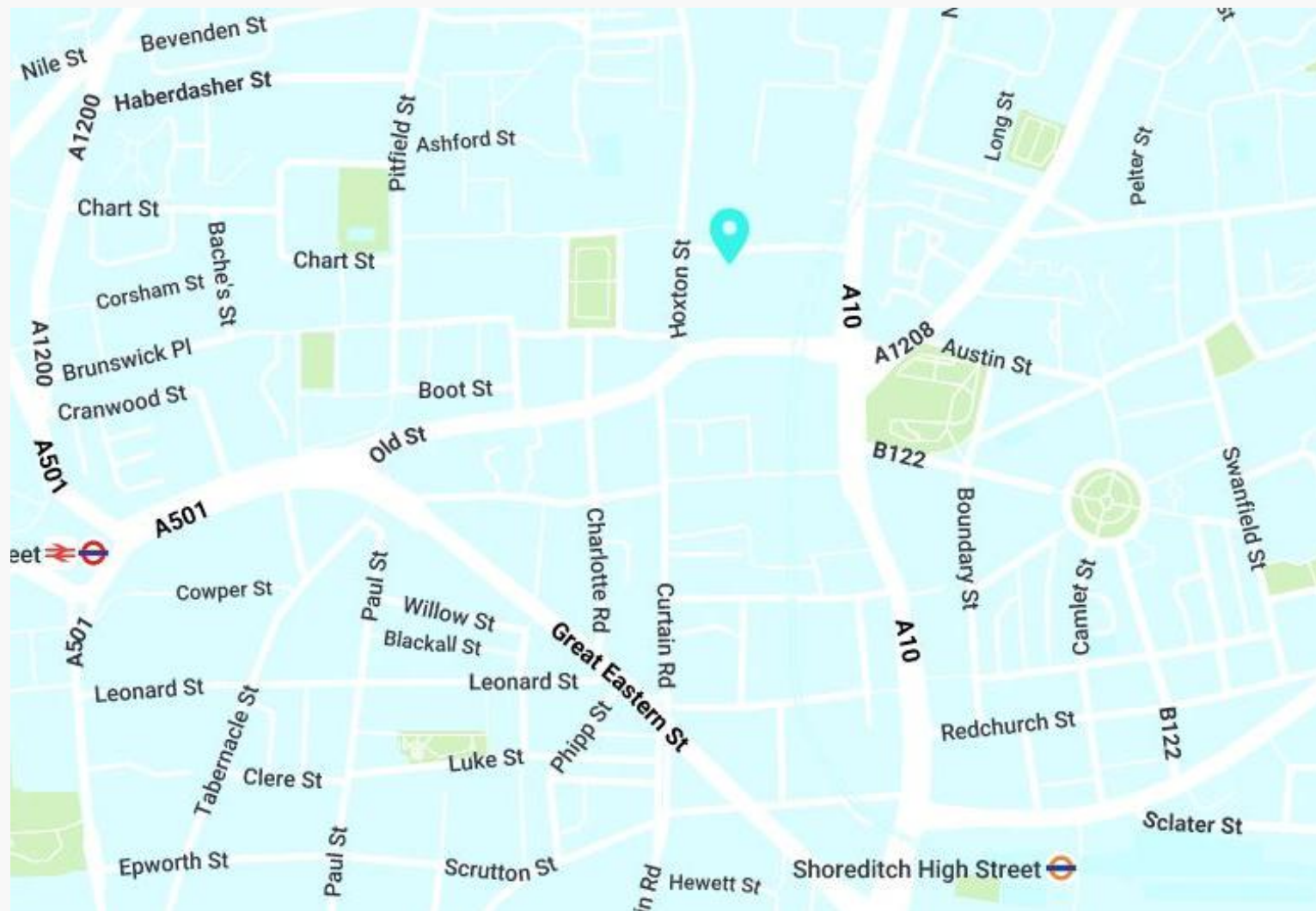


AREA
