LOCATION

Harpenden is an affluent, attractive commuter town in the county of Hertfordshire. It is situated some 30 miles north of Central London, some 5 miles north of St Albans. It benefits from excellent communications being close to the M1 motorway and has direct train services into London St Pancras.

The core population of Harpenden is 30,674 (2021 Census) and is considered to be one of the wealthiest towns in Hertfordshire. 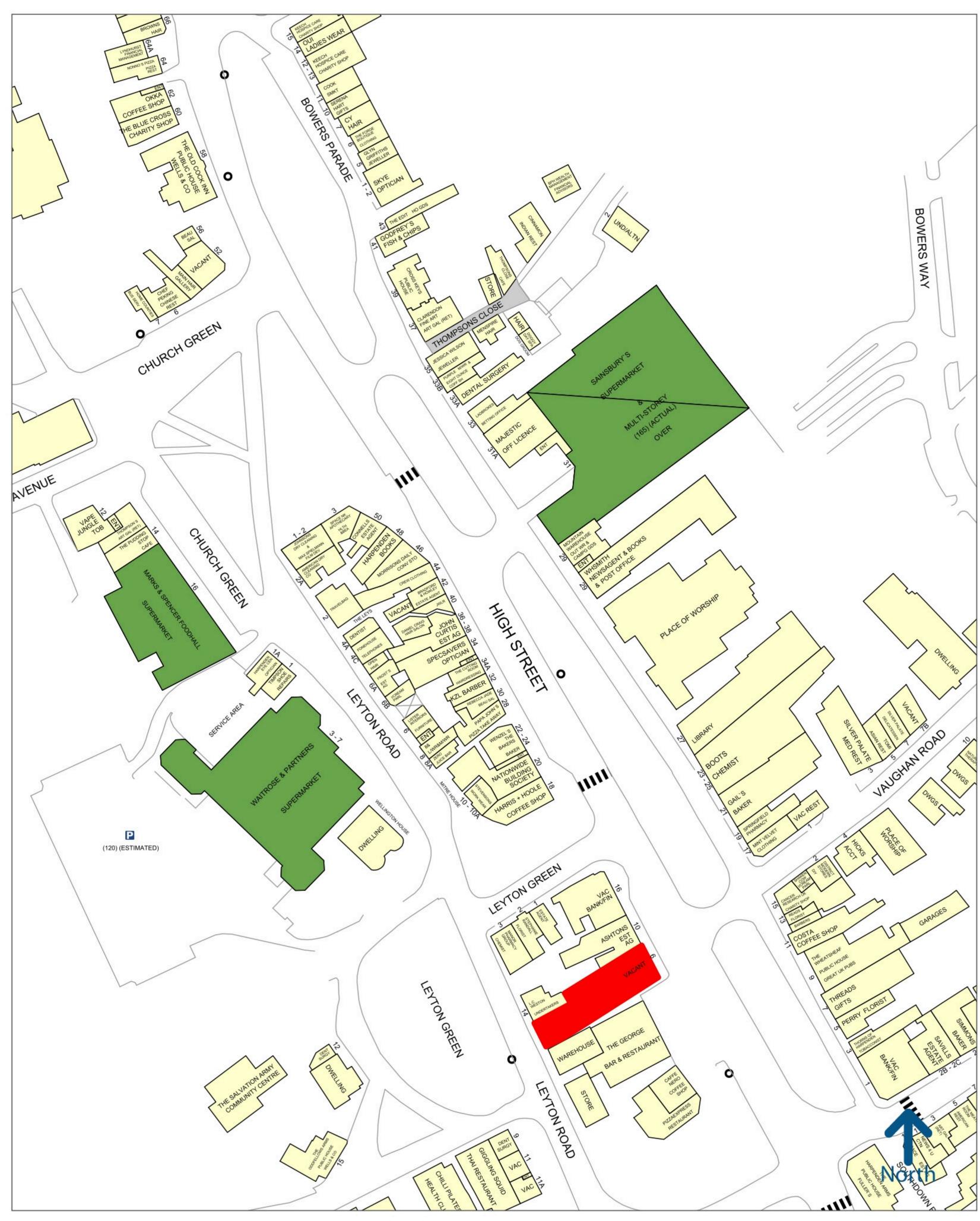
