Location

Fareham is a popular town located in south east Hampshire. It is located just off Junction 11 of the M27, approximately 10 miles to the east of Portsmouth and 20 miles to the west of Southampton.

Description

This ground floor lock up retail premises benefits from a main open plan sales area with ancillary storage/back of house facilities to the rear. Also located to the rear is a single disabled WC. To the front of the premises there is an opportunity for outdoor seating.
