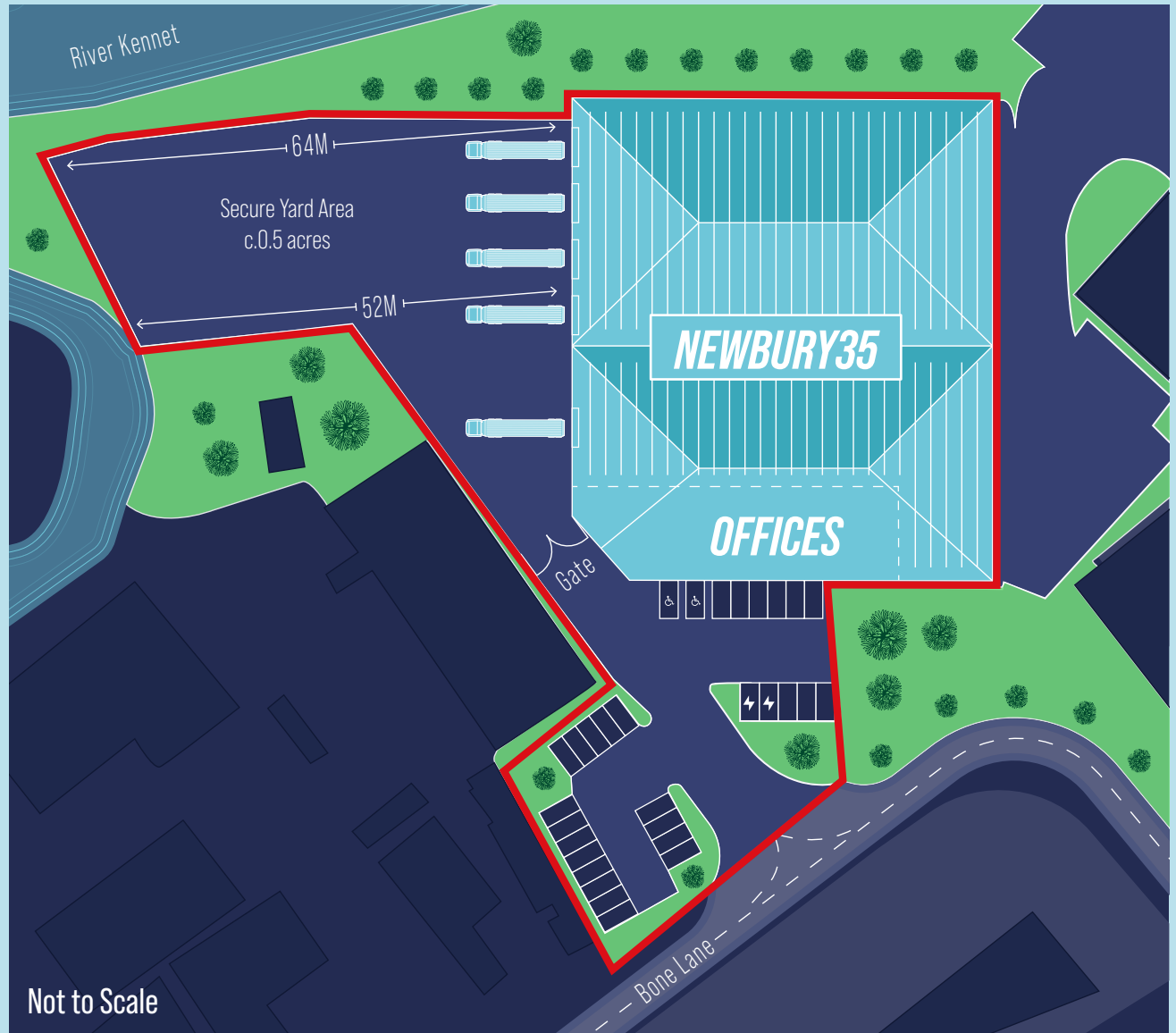

The building benefits from a large secure yard and generous car parking provision. Ancillary office accommodation is provided at first floor.

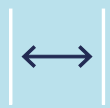

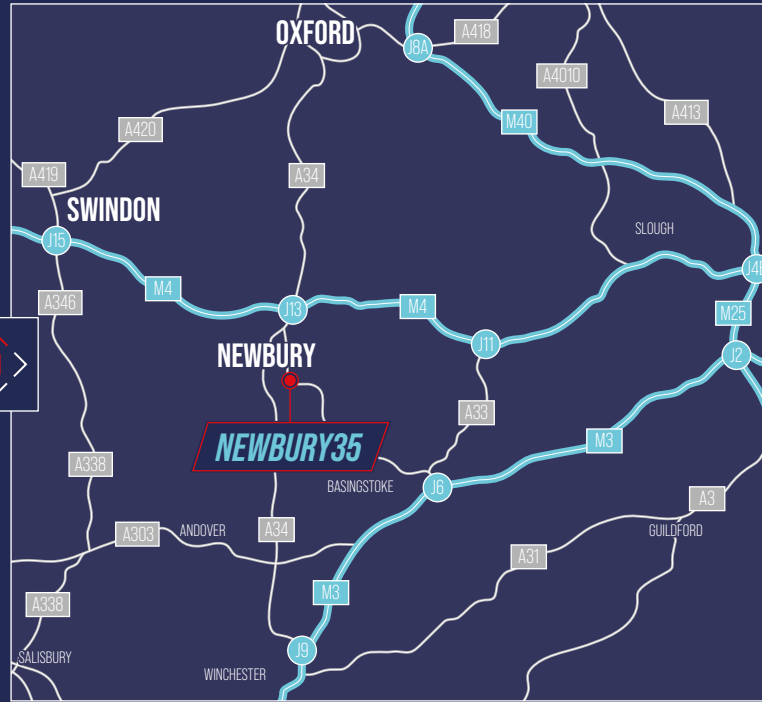
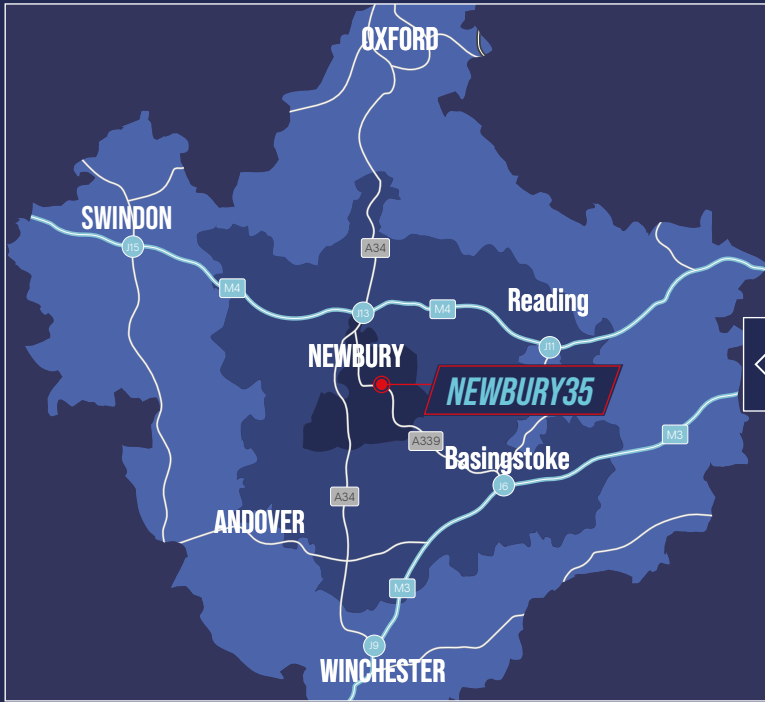

Newbury, in West Berkshire, is centrally located in the M4 corridor, and situated approximately 53 miles west of Central London, and 25 miles south of Oxford. The town benefits from excellent road communications being situated at the intersection of the M4 (Junction 13) and the dual carriageway A34/A339 which is the key route between Southampton and the South Coast, with Oxford, Birmingham and the Midlands to the north. Newbury Station provides excellent rail links with an approximate journey time to Reading of 25 minutes and London (Paddington) of 52 minutes.
