Hoxton 0.3 Miles



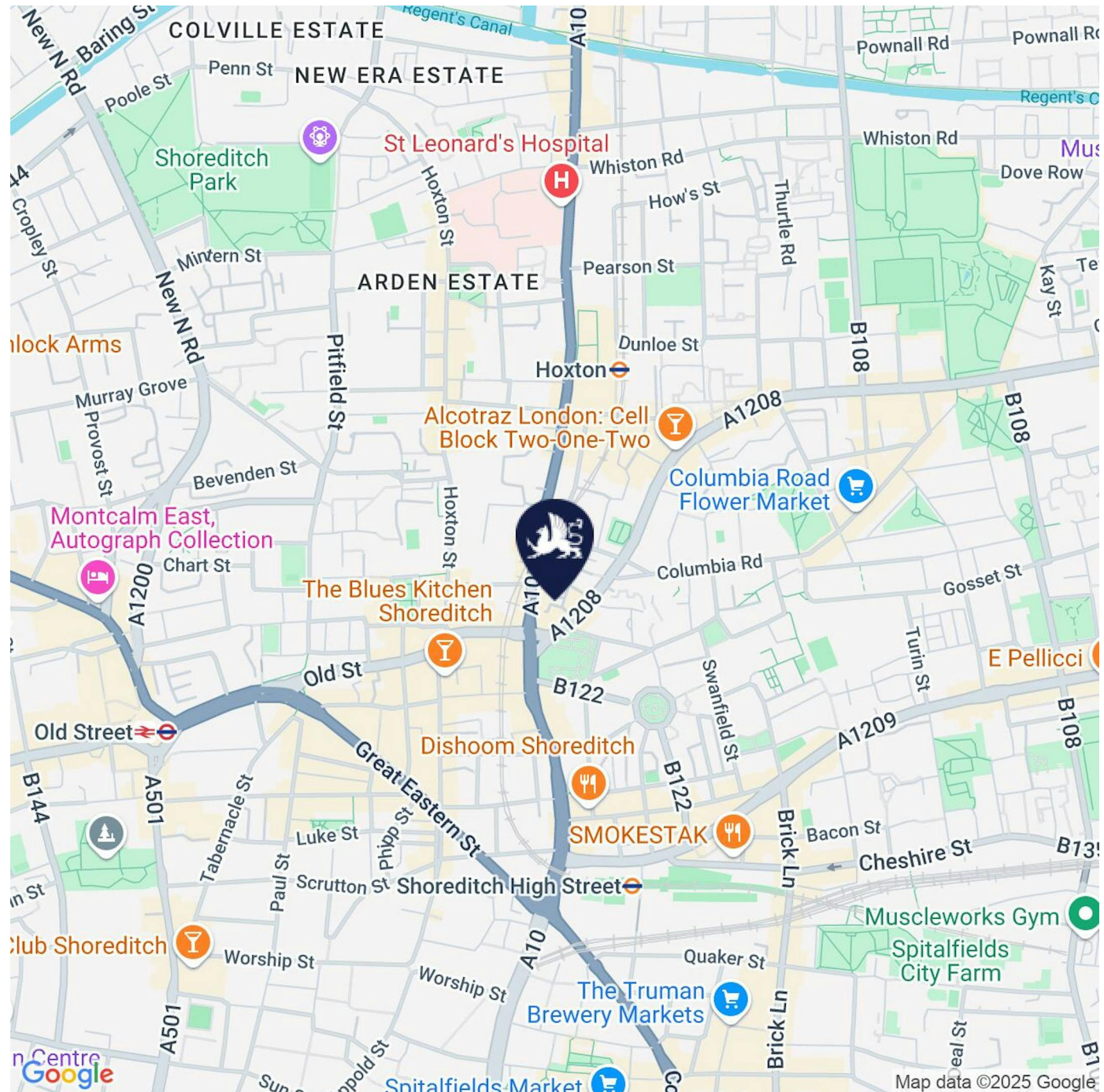
Shoreditch High Street 0.3 Miles

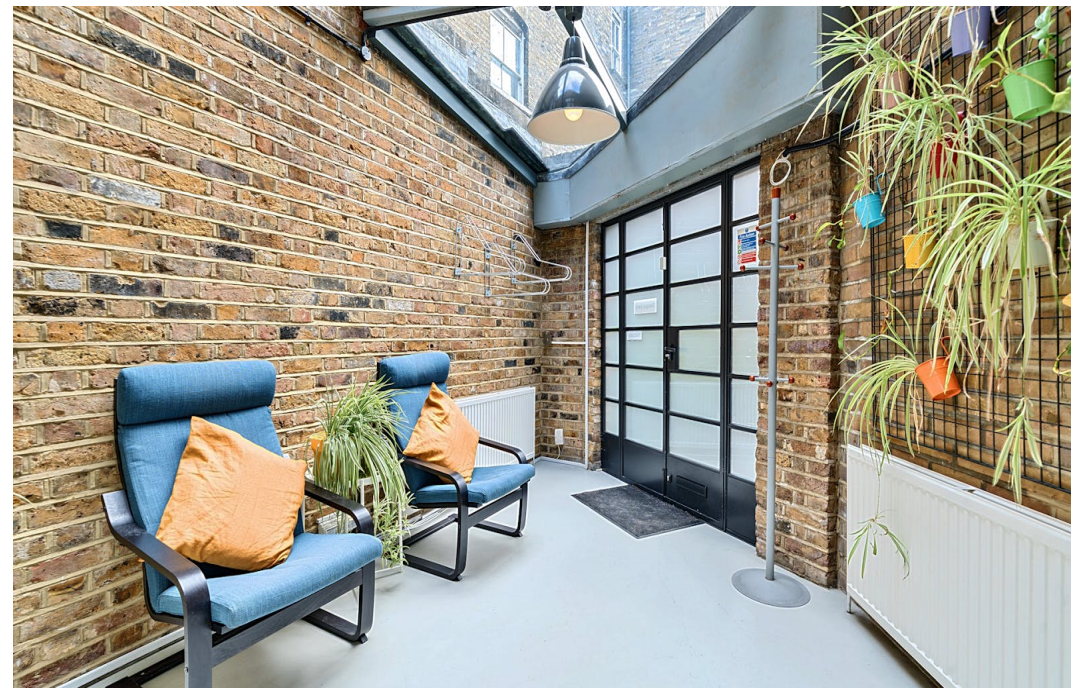


Old Street 0.5 Miles
