Description

The self-contained accommodation is arranged over the ground floor, with the opportunity to take on the lower ground floor, which is presently in shell condition.

The ground floor benefits from an excellent floor-to-ceiling height of approximately 3.64 metres and enjoys strong levels of natural light via the double frontage, as well as a rear skylight and side lightwell.

The space is DDA compliant, includes a large WC, and is fitted with air conditioning throughout (not tested). The unit is currently configured as a travel agency.

Location

The premises are situated on the east side of Margaret Street close to the junction with Great Titchfield Street.

Oxford Circus Underground Station (Bakerloo, Victoria and Central) is about a 5 minute walk away.







