


An impressive 19,500 sq ft HQ/ Campus opportunity suitable for a range of uses.




Description

Dating back to 1939, this former drill hall training facility was an integral facility for the armyd reserves. The building has been carefully and considerately refurbished to provide an impress ive balance of historic character and modern facilities. The building provides scope to offer an impressive private reception or ground floor cafe/ retail element. The ground dand mezzan ine levels provide high quality accommodation with access to private external dcourtyards. The upper floors provide open plan configurations with an extensive roof terrace on the 1st floor a nd an impressive vaulted ceiling lined with skylights on the 2nd floor.

Location

A few minutes walk to Stepney Green Station and just an 8 minute walk to the Elizabeth line, travel times from Whitechapel to Liverpool Street 3 minutes; Bond Street 10 minutes; Heathrow 41 minutes. A vibrant cultural and lifestyle hotspot, featuring a variety of local amenities. The neighbourhood is filled with an array of dynamic dining spots, coffee houses, bars, and shops.
