## Location

- Located in Henty Road, Shirley, close to Shirley High Street and accessed from Oakley Road and Shirley Park Road
- Main access out of the City to the motorway network is via Tebourba Way, which leads to the A35 and the M271/M27 Junction 3 which also provides quick access to the M3
- Southampton City Centre and Southampton Central Station is no more than a 10 minute drive with links to London's Waterloo or West to Bournemouth

## Description

- The premises form part of an industrial site known as Henty Works
- The industrial unit is located at the rear of the site and accessed via secure railed fencing at the front
- Small office to the front of the unit
- Warehouse storage with an eaves height of 3.05m min – 3.6m max
- Loading door to the front of the unit

## Lease

The premises are available on a new full repairing and insuring lease for a term to be agreed, with periodic rent reviews.

## Rent
