DESCRIPTION

The opportunity is arranged over ground floor level and was most recently operated as a salon. The premises are fitted to a good standard, benefitting from a suspended ceiling, comfort cooling, LED panel lighting and LVT flooring throughout.

The existing fit-out includes four hair washing stations, five styling chairs, two WCs and a kitchenette. Excellent natural light is provided via the frontage and a large easterly-facing skylight to the rear.
