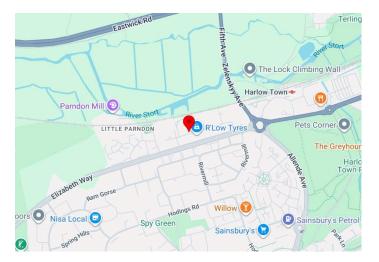

## **Description**

The property comprises a mid-terrace industrial/trade counter unit concrete frame construction with brick and block infill.
