LOCATION

The subjects are located within the town and former royal burgh of Jedburgh in the Scottish Borders. The town is found on the A68 - a key arterial route connecting the Scottish Borders and Northumberland and is 10 miles from the Carter Bar pass.

Jedburgh is located approximately 48 miles to the south of Edinburgh and around 57 miles to the north of Newcastle. It is situated around 55 miles from both Edinburgh and Newcastle Airports.

Allerton House is located in a largely residential area - which is close to Jedburgh Town Centre. Its location allows easy access to local amenities in less than 10 mins walk. The town has many historic sites alongside being a key stop off on St Cuthberts Way and Borders Abbey Way.



DESCRIPTION

Allerton House is an attractive detached Georgian house arranged over ground and first floors. Internally, access is directly via a large entrance hall. The property is bursting with great period features.

The ground floor is home to two ensuite guest bedrooms, alongside the property's dining room. Other areas on the ground floor include the guest house kitchen, laundry, hall and pantry. There is also access to the owner's accommodation which includes a modern kitchen and living room at this level.

The first floor contains a further four ensuite bedrooms, study, and the first floor of the owner's accommodation. The ground floor and first floor of the owner's accommodation is connected via private stairway.

Allerton House Stables is an attractive converted building of two storeys, with modern open plan living room / kitchen, and first floor double bedroom.

The house is set on beautiful landscaped graded lawns and a large tarmacadam driveway.
