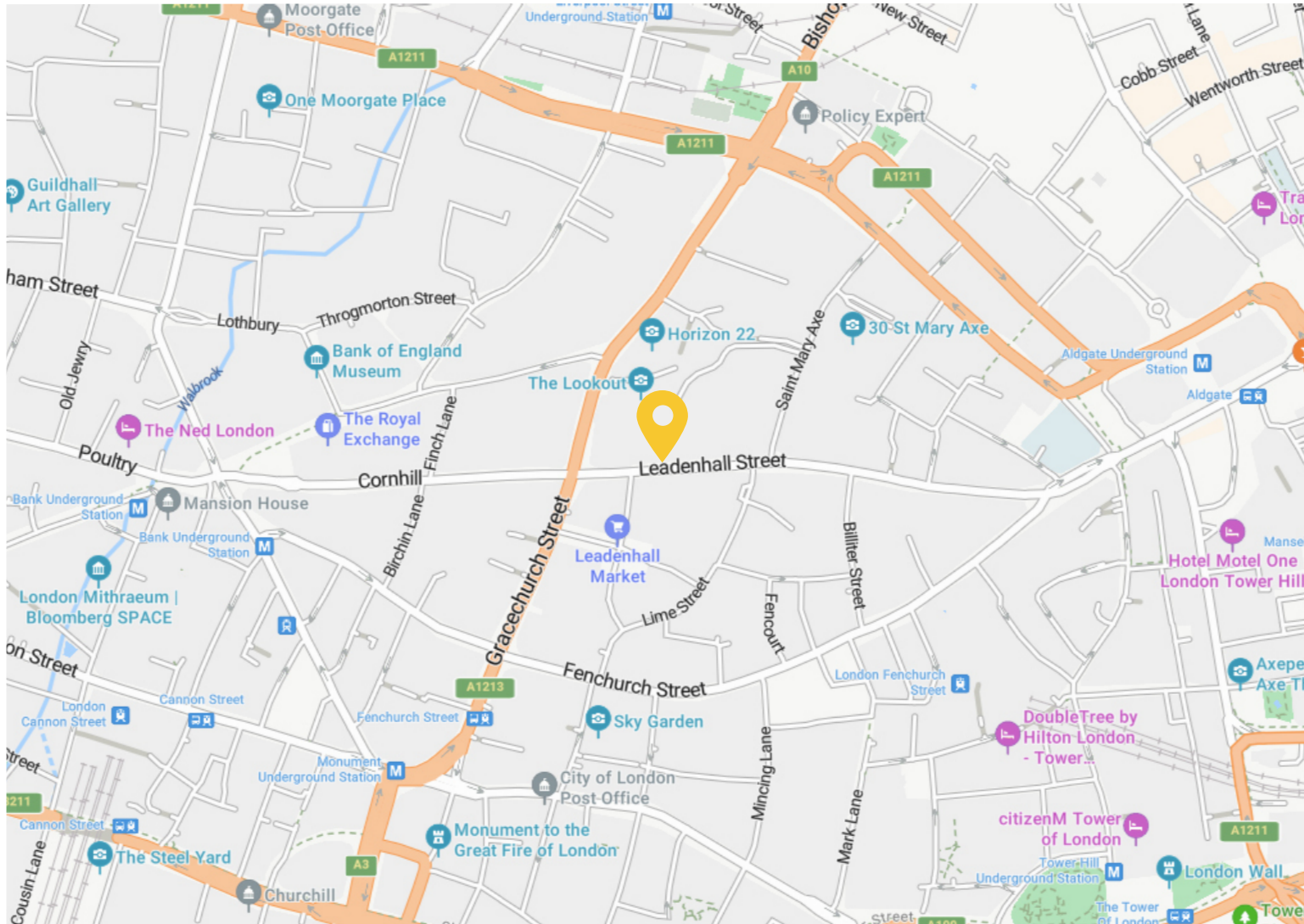
Floorplan
