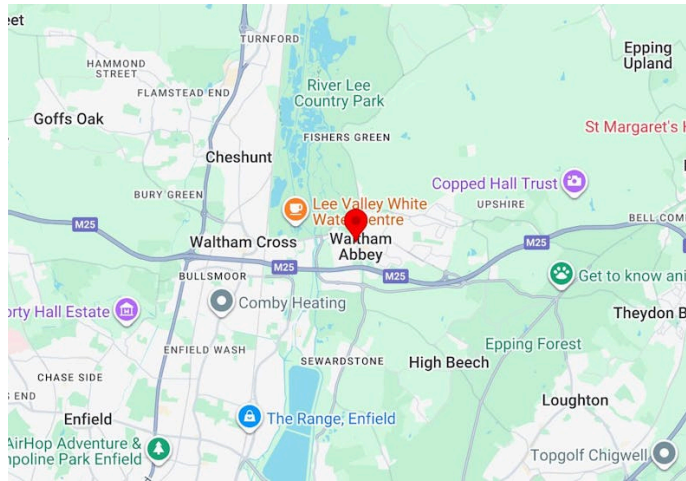

## Description

Newmet House comprises a former detached dwelling believed to have been constructed in the early part of the 20th Century which has for many years been used for administrative offices.

The property was subsequently extended in the 1950s/1960s to provide an extensive two storey factory component, part of the first floor of which is currently used for further offices and research and development purposes. Newmet House benefits from forecourt parking.

Fordoun House comprises a single storey warehouse building which currently incorporates a substantial mezzanine floor. Six car parking spaces are allocated to Fordoun House within a shared car park.

## Location

The property is situated on the edge of Waltham Abbey town centre close to Waltham Abbey town centre with

its extensive range of service providers and eateries. A Tesco supermarket is within 5 minutes walk of the premises. Waltham Abbey is situated on the borders of Essex, Hertfordshire and North and East London with good access to Junction 26 of the M25 serving the national motorway networks. Numerous bus routes serve the town and the nearest railway station is at Waltham Cross.
